6. Administrator's Report, Complaints and Communications.

Task Force Administrator Cheryl Leger presented the Administrator's Report and responded to questions.

Marc Bruno stated that he wants the general public to get help and not be discouraged by the Sunshine Process and encourages people to send items in pdf format and not use NextRequest because it is an obstruction.

File No. 23080 Complaint filed by Marc Bruno against Patrick Hannan and the Department of Building Inspection for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21 by failing to provide public records in a timely and/or complete manner.

Vice-Chair Stein stated that the petitioner received the photos very late, and the Complaint Committee recommends finding a violation of Administrative Code, Sunshine Ordinance Section(s) 67.25.

Action: Moved by Member Anderson, seconded by Member Wolfe, to accept the recommendations of the Compliant Committee to find that the Department of Building Inspection violated Administrative Code (Sunshine Ordinance), Section 67.25, by failing to respond to an Immediate Disclosure Request in a timely and/or complete manner

9. **File No. 22057**: Complaint filed by Stiliyan Bezhanski against Chanbory Son and the Planning Department for allegedly violating California Public Records Act, Section(s) 6254(c)(k) regarding failure to redact personal contact information.

Stiliyan Bezhanski (Petitioner) stated he wanted to close the complaint.

Jonas Ionin (Planning Department, Respondent) concurred with the Petitioner.

Public Comment:

None.

No action was taken by the Task Force, and the complaint was closed.

10. **File No. 23002** Complaint filed by Stiliyan Bezhanski against Debra Lew and the Office of the Treasurer and Tax Collector for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.25, and California Government Code Section(s) 6253(c), by failing to respond to an Immediate Disclosure Request in a timely and/or complete manner.

Stiliyan Bezhanski (Petitioner) provided a summary of the complaint and requested the Task Force find a violation. Mr. Bezhanski stated that he submitted an Immediate Disclosure Request on December 8, 2022 and there was a substantial delay in receiving the records. Mr. Bezhanski stated that the most common excuse for not providing records was attorney/client privilege. Mr. Bezhanski stated that his requests were not responded to in a timely manner.

Christopher Tirrell (Office of the Treasurer and Tax Collector, Respondent), provided a summary of the department's position. Mr. Tirrell stated that his office received Mr. Bezhanski's request. However, reviewing the records took a substantial amount of time as the department had to pull over 250 emails with attachments that exceeded 500 pages. Mr. Tirrell stated that his office released 257 documents. Mr. Tirrell stated that this requestor always submits Immediate Disclosure Requests and that staff works to respond quickly. Mr. Tirrell stated that his office responded on December 9, 2022.

A question and answer period occurred. The parties were provided an opportunity for rebuttals.

11. **File No. 22114** Complaint filed by Michael Petrelis against Jonas Ionin, President Diane Matsuda and the Historic Preservation Commission, for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.15, by failing to provide an

opportunity for members of the public to address the body of interest that are within the body's jurisdiction (General Public Comment - October 5, 2022, meeting).

Michael Petrelis (Petitioner) provided a summary of the complaint and requested the Task Force find a violation. Mr. Petrelis stated that this case is about intimidation and freedom of expression. Mr. Petrelis stated he attended a Historic Preservation Commission meeting and was carrying a sign that referred to the Castro Theatre. Mr. Petrelis stated that the Commission Secretary was using tactics to try to intimidate Mr. Petrelis and seemed to want him to give up his three minutes of public comment time.

Jonas Ionin (Historic Preservation Commission, Respondent), provided a summary of the department's position. Mr. Ionin stated that Mr. Petrelis was holding a sign about the Castro Theatre and the Chair interrupted the speaker to clarify what that person was commenting about. Mr. Ionin stated that this is done in practice all the time. Mr. Ionin stated that the comments were related to the Castro Theatre and Mr. Petrelis was allowed three minutes to speak.

A question and answer period occurred. The parties were provided an opportunity for rebuttals.

Action: Moved by Vice-Chair Stein, seconded by Member Anderson, to find no violation.

12. **File No. 22119** Complaint filed by Michael Petrelis against Supervisor Rafael Mandelman (Board of Supervisors) for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.29-5, by failing to provide required calendars of certain officials in a timely and/or complete manner.

Michael Petrelis (Petitioner) provided a summary of the complaint and requested the Task Force find a violation. Mr. Petrelis stated that he gives full credit to Supervisor Mandelman's staff for providing the Supervisor's Prop G calendar in a timely and/or complete manner.

Calvin Ho (Supervisor Mandelman's Office, Respondent), provided a summary of the department's position. Mr. Ho stated that his office has been diligently responding to Prop G calendar requests in accordance with Administrative Code 67.29-5 and have made every effort to fulfill these requests.

A question and answer period occurred. The parties were provided an opportunity for rebuttals.
