of the LAFCo General Policies and Procedures. (Discussion and Possible

Action Item)

As directed by the Commission, staff has brought the attached resolution before the Board to revise Section 1.410 of LAFCo's General Policies and Procedures.

Under section 53675 of the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, the Commission has the power to adopt written procedures governing its operations, including the evaluation of proposals, services plans, and to ensure the orderly and fair conduct of hearings by the Commission.

As it is currently written, policy section 1.410 states: "The office of chair and vice chair are one year terms. No Commission member shall serve more than two consecutive one year terms in the same office."

As the attached resolution reflects, the Commission would delete the second sentence of policy section 1.410, thereby allowing a member to serve as chair or vice-chair for more than two consecutive terms. The Commission has recognized that in some circumstances, it may be in the best interest of LAFCo for a Commissioner to continue in one of these offices for more than two years.
