**Background**: This item was continued from last month and the Commission requested that all approved bidders be given the opportunity to bid on oversight tasks. The oversight program was identified in the original Request for Qualifications released in November 2007. The oversight program has been provided by existing staff up to this date. Oversight activities include the following tasks:

- a. Analyze the technical sufficiency of the SFPUC's administration of Clean Power SF.
- b. Analyze the procedural sufficiency of the SFPUC's administration of Clean Power SF.
- c. Recommend to SF LAFCo improvements to Clean Power SF to assure its success.
- d. Monitor and possibly apply for grants, fees, and other allocations from federal, state, and local agencies and private entities that may be available for the advancement or benefit of Clean Power SF.
- e. Review draft policies and procedures that would govern the development, implementation, operation, or management of Clean Power SF.
- f. Review Request for Information and Request for Proposals documents prepared by SFPUC and advise of their completeness and consistency with the Implementation Plan.
- g. Report the results of any review to SF LAFCo and/or the Board of Supervisors with recommendations for changes.
- h. Propose modifications to the Implementation Plan in light of additional information and further progress in development of Clean Power SF.

j. Present findings, conclusions, and recommendations related to assigned tasks to SF LAFCo and the Board of Supervisors.

SF LAFCo has been providing these services through existing staff. We are scheduled to hire a full time person within the next few weeks and our ability to provide oversight tasks with existing staff will increase. However there are some tasks that need special input and advice. At this time, the Interim Executive Officer believes that the potential tasks for the oversight program would be most economically provided by a selected consultant on an on-call, as-needed basis.

Request for Proposals: In order to select a consultant who could provide the on-call, as-needed services for the oversight program, the Interim Executive Officer released a Request for Proposals to all qualified bidders on June 16, 2009. A copy of the Request for Proposals is attached to this report.

The consultants were asked to provide a proposal meeting the requirements of the Request for Proposals by Monday, June 22, 2009, at 5:00 p.m. All of the consultants who received the request submitted responses. George E. Sansoucy, P.E., LLC, transmitted a letter stating they would be unable to submit a proposal because of the conflict with the work they are already contracted with the SFPUC to complete. Three other qualified consultants timely submitted proposals:

- 1. Local Power, Inc.
- 2. Navigant Consulting, Inc.
- 3. MBMC, Inc.

A copy of each of the submitted proposals is attached to this report.

<u>Summary of Proposals</u>: Each of the submitted proposals meets the minimum requirements of the Request for Proposals. The following is a short summary of parts of each proposal.

### Local Power, Inc.

Local Power, Inc.'s (LPI) proposal includes a suggested approach for each task. LPI proposes a price of not-to-exceed \$12,800 per month. The rates for potential staff range from \$100 - \$325 per hour. LPI states that staff will be available as-needed. LPI discloses one potential conflict in that it is preparing a "Best Practices and Lessons Learned" report for the SFPUC. LPI does not believe it would conflict with the oversight project.

# Navigant Consulting, Inc.

Navigant Consulting, Inc's (NCI) proposal includes an estimate of the cost for each task. NCI proposes a total budget for all 10 tasks of \$100,000. The budget is not a precise estimate since services will only be provided as specifically requested by SF LAFCo as-needed. The rates for potential staff range from \$132 - \$428 per hour. NCI states that staff will be available as-needed and John Dalessi will be the project manager and primary point of contact. NCI discloses no potential conflicts.

## MBMC, Inc.

Michael Bell Management Consulting, Inc.'s (MBMC) proposal includes a suggested approach for each task. However, MBMC states it is does not have the resources to perform Task d, and suggests using another consultant for that task. Mr. Bell states it is difficult to accurately estimate costs without more detailed scopes-of-work available but he is available on a not to exceed basis once the tasks are defined. His rate is \$215 per hour. Mr. Bell states MBMC has no conflicts.

Prior to coming to Navigant Consulting, Mr. Welch was responsible for the long-term natural gas portfolio for Pacific Gas and Electric Company's four million core customers, including the hedging

# Clean Power SF Advisory/Monitoring Project

## Introduction

Michael Bell Management Consulting, Inc. (MBMC) is uniquely qualified to provide the San Francisco Local Agency Formation Commission (SF LAFCo) with the high level consulting and advisory services that it desires in connection with the Community Choice Aggregation (CCA) Program for the City and County of San Francisco (CCSF). Mr. Michael Bell has extensive public utility management experience, having been a senior executive for electric, water and telecommunications utilities in California and Illinois. For the last decade, Mr. Bell has managed consulting assignments for numerous public agencies including several assignments with Bay Area organizations such as the SF LAFCo, SF PUC, East Bay Municipal Utility District, the City of Palo Alto Utilities, Port of Oakland, Contra Costa Water District, and the Santa Clara Valley Transportation Agency. For eight years he managed the California operations of a major national consulting firm serving the electric, water, wastewater and solid waste industries.

MBMC proposes an arrangement by which the SF LAFCo could delegate assignments as needed and agreed to in individual detailed scope of work and task orders. Mr. Bell has a history of providing consulting and advisory services in a timely and professional manner to the SF LAFCo, and looks forward to continuing to do so in the future.

# **Task Approach and Price Proposal**

MBMC is prepared to perform all but one of the tasks identified in the Request for Proposals (Task d). A discussion of the project approach and cost estimate for each of the Tasks identified in the Request for Proposals is contained in this section of the response.

It is proposed that each Task be more thoroughly defined when SF LAFCo is prepared to proceed, resulting in a detailed scope of work and not-to-exceed price agreement based upon full and complete data at the time. It is somewhat difficult to provide a definitive not-to-exceed amount without knowing the number of reports or potential responses to CCSF's ongoing solicitations. Therefore, it is recommended that as each Task is embarked upon an agreement as to the hours, expenses, and not-to-exceed amount be determined based upon information and data available at that time. For purposes of this Proposal, estimates of cost are provided based upon considerable past experience with similar work for SF LAFCo.

# a. Analyze the technical sufficiency of the SFPUC's administration of Clean Power SF

Given the previous work that has been performed for SF LAFCo, Mr. Bell is familiar with the goals, objectives and plans for the development of CCA in San Francisco and the desire to achieve as green a power supply portfolio as possible while improving service and reliability at the same time. With 30 years of experience in the industry Mr. Bell has the knowledge and experience to review the analysis and conclusions of the SF PUC consultants and staff and determine if the assumptions used and conclusions reached are reasonable from both a technical and policy standpoint.

It is estimated that the cost to provide the technical sufficiency analysis would be approximately \$23,000.

#### b. Analyze the procedural sufficiency of the SFPUC's administration of Clean Power SF

Mr. Bell is familiar with both the laws and procedures that CCSF must comply with in order to implement CCA, as well as the goals established by the Board of Supervisors and SF LAFCo for the implementation of CCA in San Francisco.

It is estimated that the cost to provide the procedural sufficiency analysis would be approximately \$18,000

#### c. Recommend to SF LAFCo improvements to Clean Power SF to assure its success

Much of the current structure for implementation of CCA in San Francisco is the result of previous recommendations that Mr. Bell has made in four previous SF LAFCo engagements. Given this familiarity and his industry technical knowledge, few if any, other consultants could provide the consistency and knowledge of the development and progress of CCA in San Francisco. He is entirely familiar with the considerable record to date. Other consultants would need to spend considerable time bringing themselves up to speed, adding to the cost of their proposals.

Another advantage is the fact that Mr. Bell is totally independent. Many of the qualified respondents to the SF LAFCo RFP's are already working for SF PUC on this project. Even though there may be no actual conflict of interest, there is the possibility that some of the parties following CCA progress could perceive there to be a conflict, particularly when consultants employed by SF PUC are tasked with providing independent advice to SF LAFCo. Such arrangements could also potentially cause friction between consultants engaged by SF PUC. Mr. Bell has purposely avoided working for SF PUC on this project in order to maintain this independence for the benefit of SF LAFCo.

It is estimated that the cost to provide recommendations for improvements would be approximately \$18,000.

d. Monitor and possibly apply for grants, fees, and other allocations from federal, state, and local agencies and private entities that may be available for the advancement or benefit of Clean Power SF.

This is the one Task that MBMC believes that SF LAFCo would be better served to employ another consultant with the resources to track and respond to potential grants and other funding mechanisms that could help with funding Clean Power SF. As a sole proprietor Mr. Bell does not have the time or the resources to effectively keep track of such options. He would be happy to coordinate assigned Tasks with consultants of SF LAFCo that perform this function.

e. Review draft policies and procedures that would govern the development, implementation, operation, or management of Clean Power SF.

Mr. Bell's familiarity and input with the development and progress of the Implementation Plan provide a sound basis for continued review and input as policies and procedures are considered. He has already made numerous recommendations to SF LAFCo which has resulted in policy level direction to SF PUC.

It is estimated that the cost to draft policies and procedures would be approximately \$18,000.

f. Review Request for Information and Request for Proposals documents prepared by SFPUC and advise of their completeness and consistency with the Implementation Plan.

Mr. Bell has worked as project manager for the SF LAFCo on four separate engagements. These include the following:

- SF LAFCo Energy Services Study, July 2002
- AB 117 Assessment Report for the City and County of San Francisco, August 2003
- Electric Financial Feasibility Study, January 2004
- Community Choice Aggregation Suggested Implementation Plan, Request for Qualifications, and Request for Proposal Modifications, June 2008

The most recent of these assignments provided precisely the type of information that this Task seeks to fulfill. Mr. Bell is familiar with the process that has brought the CCSF to the point at which they are today, and with the activities that need to be accomplished in order to establish CCA in San Francisco.

It is estimated that the cost to review the Request for Information and Request for Proposals would be approximately \$30,000.

g. Report the results of any review to SF LAFCo and/or the Board of Supervisors with recommendations for changes.

Mr. Bell is prepared to review and provide independent evaluation and recommendations to SF LAFCo and/or the Board of Supervisors for most any report or analysis drafted in preparation for CCA implementation.

The cost of this Task would be dependent upon the review that is needed. It is suggested that a scope of work and not-to-exceed cost be agreed to when SF LAFCo and/or the Board of Supervisors determine exactly what reports need to be reviewed.

# h. Propose modifications to the Implementation Plan in light of additional information and further progress in development of Clean Power SF.

As stated in MBMC's most recent report to SF LAFCo in Community Choice Aggregation – Suggested Implementation Plan, Request for Qualifications, and Request for Proposal Modifications,

"All of the items discussed in the Potential Changes to the RFQ/RFP have the potential of impacting the IP over time. Therefore, it is appropriate to periodically review the IP in light of these developments. It is recommended that the IP be reviewed again after responses to the RFQ are received, and after the selection of a supplier emerges from the RFP process. It will undoubtedly need review as implementation progresses."

It is appropriate and desirable for SF LAFCo to periodically review and modify the Implementation Plan based upon new and updated information. There is unprecedented change taking place in the energy industry including competitive pressures, technological change, and regulatory impacts. It is in the interest of San Francisco to periodically pause to review the Implementation Plan and make changes that may be needed.

It is estimated that the cost to propose modifications to the Implementation Plan would be approximately \$30,000.

# i. Request from the SFPUC all data and work product obtained and/or developed necessary to support any review or analysis of Clean Power SF undertaken by SF LAFCo or the Board of Supervisors

Mr. Bell has an extensive history of working with SF PUC and others in order to acquire and understand data and work product prepared by others. He has good knowledge of and familiarity with SF PUC staff, and has a good working relationship with SF PUC employees.

The cost of this Task is included in the estimates provided above.

# j. Present findings, conclusions, and recommendations related to assigned tasks to SF LAFCo and the Board of Supervisors

Mr. Bell has considerable experience presenting findings, conclusions and recommendations to the SF LAFCo. He also has extensive experience relaying such information to the public.

The cost of this Task is included in the estimates provided above.

## Other Information

Mr. Michael Bell is the only individual that will perform work on the proposed Tasks. A copy of his resume is attached to this proposal. Mr. Bell is willing to work with other consultants should SF LAFCo desire to employ a team of consultants for any or all of the proposed Tasks. Mr. Bell bills an hourly rate of \$215 per hour, and bills project expenses at cost. He will agree to a not-to-exceed amount for an agreed upon scope of work. Mr. Bell will not commit to perform work or agree to a due date that he cannot successfully complete within the agreed upon budget and time constraints. The four projects completed for SF LAFCo bear witness to this fact.

Mr. Bell is not aware of any potential conflicts of interest. As stated earlier in this proposal, Mr. Bell has purposely avoided working for SF PUC in order to ensure that there is no potential conflict of interest for work performed for the SF LAFCo. He provides the SF LAFCo with a valuable option given the fact that a number of its qualified consultants are performing other work for SF PUC.
