This item is the result of a meeting between Commissioner Bornstein, staff from the SFPUC, and Local Power, Inc., regarding the next steps in the development of the CCA Program.

Under the current CCA Program schedule, the next steps to be undertaken by SFPUC and SF LAFCO include revising the Draft Implementation Plan based on the recommendations provided by Michael Bell, and preparing a Program Basis Report.

I recommend that you authorize the Executive Officer to meet with the SFPUC to further develop the next steps and necessary tasks for the development of the Program Basis Report, including but not limited to the seven tasks included in this agenda item. These tasks will be developed with sensitivity to the current CCA budget, the need to implement the CCA Program with all due diligence, and to be consistent with the scope of work set forth in the Joint Request for Qualifications released November 21, 2007.

Attached, please find a cost proposal from Local Power, Inc. on the seven tasks included in this agenda item.
