# **Regular Meeting**

**Present:** Commissioners Connie Chan (Chairperson), Jackie Fielder (Vice Chairperson), Gordon Mar, and Shanti Singh

The San Francisco Local Agency Formation Commission (SF LAFCo) met remotely in regular session through videoconferencing, and provided public comment through teleconferencing, on Friday, July 15, 2022, with Chair Connie Chan presiding.

Chair Chan called the meeting to order at 10:04 a.m.

# 1. Call to Order and Roll Call

# 2. Findings to allow Teleconferenced Meetings Under California Government Code, Section 54953(e)
