## **Regular Meeting**

**Present:** Commissioners Fielder, Sevier, Singh, and Williams

*The San Francisco Local Agency Formation Commission (SF LAFCo) met in person in regular session, and provided public comment through teleconferencing on Friday, January 16, 2026, with Chair Jackie Fielder presiding.*

*Chair Fielder called the meeting to order at 10:02 a.m.*

### **1. Roll Call and Communications**

*On the call of the roll, Commissioners Fielder, Sevier, Singh, and Williams were noted present.*

**3. CleanPowerSF Updates**

*Cheryl Taylor, Operations Manager (CleanPowerSF), Matthew Freiberg, Rates Manager and Kieran Yater, Utility Analyst (San Francisco Public Utility Commission) provided a presentation on the update on CleanPowerSF on the enrollment and services statistics, customer programs update, mid-year proposed rate change, and gas decommissioning and rates and answered questions raised throughout the discussion.*

**4. Appointment of One Public Member, Term Ending February 22, 2030**

*Seat 5, Isaac Sevier, must be a public member-at-large appointed by the Local Agency Formation Commission, for a four-year term ending February 22, 2026*

**5. Executive Officer Report**

He also reported on the Policy Analyst recruitment process and outlined next steps, including convening a selection panel and initiating interviews, which are anticipated to be ready for the March 20, 2026, LAFCo meeting. In addition, he presented the proposed forward calendar for the March, May, and July 2026 LAFCo meetings.*
