III. Report of the President - Diane B. Wilsey

President Wilsey made an announcement that could not be noted on the agenda since she had only just received the news hours earlier. Mrs. Wilsey announced that she has good news and bad news, and they are both the same thing – that Colin Bailey informed her earlier in the day he has accepted the position of Director at the Morgan Library and Museum in New York and is expected to leave FAMSF at the end of June. Mrs. Wilsey stated that Mr. Bailey has done everything she hoped he would do when he was hired, and elevated the intellectual stature of these two museums. He has improved the permanent collections, and has been fun, funny, and a joy to work with. Regarding anything undone that Mr. Bailey has instigated he will see to fruition. Mrs. Wilsey expressed sadness that Mr. Bailey is leaving FAMSF, but is also very happy for him.

Mr. Bailey stated that this has been the greatest experience in his museum career to lead these two museums, to have the opportunity to be a director in a vibrant and impressive community. He expressed his love for working with the staff, and he has taken great pride in seeing the growth in conservation, curatorial, and the library. The exhibitions are among the greatest achievements of any museum in the country, and FAMSF is the first port of call for exciting exhibitions originating in Europe and America.

Thanks to the support of the Board of Trustees, the Museums can say "yes" to many of these exhibitions and then raise the funds that allow us to be competitive in this field. This is not in conflict with maintaining and improving the permanent collections through endowments, purchases, and gifts. He noted that many of the Trustees present have been very generous in this regard.

Mr. Bailey stated that, as a scholarly curator, he is someone who doesn't go to archives and libraries anymore. The job of the director is to be in the community and stand for the values, standards, and aspirations that these museums and staff strive for. Alongside the wonderful collection, the staff is the Museums' greatest asset.

A. Consideration and Possible Action to Approve the Minutes of the January 21, 2015 Meeting of the Board of Trustees

There being no discussion among Trustees or comments from the public, the minutes of the January 21, 2015 meeting of the Board of Trustees, having been delivered in advance to all Trustees, were unanimously approved.

B. Strategic Projects Report on Fundraising Events and Special Exhibition Openings

In the absence of Lauren Hall, this report was given by Trustee Holland Lynch and Lisa Podos, Director of Strategic Projects and Acting Director of Development. They reported:

Pre-sale tickets for all seated galas, as well as the ArtPoint Annual Gala, sold out in advance. Gross revenue records were set in three of the five fundraisers in Q3; net figures will be presented at the next Board meeting. Strategic Projects is looking for ways to further leverage the success of these fundraisers to see further growth in key metrics of success, including: revenue streams, audience development and engagement, benefits fulfillment, sponsorships and partnerships, and PR and social media visibility.

The five Q3-Q4 fundraisers were: de Youngsters Art Party on January 9, Tribal and Textile Arts Fair Opening Night Gala on February 5, ArtPoint Annual Gala on February 7, Junior Committee Mid-Winter Gala on March 27, and Bouquets to Art on April 13.

Special exhibition openings were well-attended and tracked closely to projected guest counts. The events raised \$40,000 in event sponsorships, and also saw major donations as a direct result of cultivation efforts that occurred at opening events. One cost challenge with opening events is the consistent discrepancy between RSVP numbers and actual attendance numbers; Strategic Projects is tracking these stats to manage the financial impact.

The Art Market Benefit Preview Gala will be held on April 29.

IV. Report of the Director of Museums

A. Quarterly Report of the Director

Mr. Bailey reported that FAMSF has maintained its ranking as the fifth most-visited museum in the United States, with more than 1.5 million visitors last year, behind only the Metropolitan Museum of Art, The National Gallery of Art, and the Museum of Modern Art. FAMSF ranks 35th internationally. These visitor figures were reported in the recently-published Art Newspaper 2014.

Exhibition attendance has been tracking well. *Bouquets to Art* garnered 8,000 visitors and 3,500 have visited *Botticelli to Braque* to date. Mr. Bailey reviewed the exhibition schedule, noting that there cannot be any gaps in the planning that extends out several years. *Botticelli to Braque* is drawing strong attendance and receiving positive word of mouth. The success of *High Style* is doing extremely well, especially in retail with numerous wearable art items for sale. The final exhibition inaugurated by Mr. Bailey, starting in June, will be *J.M.W. Turner: Painting Set Free* which will include masterpieces from London and museums throughout America, including sublime watercolors and works on paper. Complimenting this exhibition will be *Luminous Worlds: British Works on Paper*, an exhibition to which many trustees have contributed.

Mr. Bailey reviewed other upcoming exhibitions that have been scheduled at the de Young and Legion of Honor through 2017. It is important when there are such important projects, for financial standing and institutional reputation, to secure good second and third venues for some of these projects.

Mr. Bailey emphasized the active, ambitious, balanced, and exciting programming of exhibitions. He reiterated that the exhibitions are the lifeblood of the institution. Without the attendance, the membership, and the retail that these exhibitions generate, the institution would not be where it is today. The challenge for the director and the staff is to balance the programs, to be aware opportunistically, to think as big as you can, and do it as well as possible. The legacy of the new de Young is to think big. The current shows, *Embodiments, High Style, and Botticelli* demonstrate that those goals can be reached and we try very hard to maintain them all the time.

Mr. Bailey thanked the Trustees for supporting these shows, and noted that they would be called on again for support through their own capacity, or through people, entities, foundations, and corporations that they can introduce. FAMSF has an amazing portfolio, but it has to be funded.

Mr. Bailey received a round of applause. There was no public comment. There was no discussion among Trustees.
