ORDER OF DETERMINATION

DATE DECISION ISSUED

CASE TITLE – David Eisenberg v. Edgar Lopez, Paul Travis, and Frank Lee,
Department of Public Works (File No. 14069)

FACTS OF THE CASE

David Eisenberg (Complainant) made a complaint alleging that Edgar Lopez, Paul Travis, and Frank Lee, Department of Public Works (Respondent), violated provisions of the Sunshine Ordinance by failing to respond to a Immediate Disclosure Request in timely and complete manner.

COMPLAINT FILED

On July 25, 2014, Mr. Eisenberg filed a complaint with the Sunshine Ordinance Task Force (Task Force) regarding the Respondent's alleged willful failure to respond to Complainant's Immediate Disclosure request in a timely manner.

HEARING ON THE COMPLAINT

On August 26, 2014, Mr. Eisenberg appeared before the Task Force and presented his claim. Frank Lee, Department of Public Works, appeared before the Task Force and presented the department's defense.

The issue in the case was whether Administrative Code (Sunshine Ordinance), Sections 67.21(b), 67.24, 67.25(a), and 67.34 were violated.

FINDINGS OF FACT AND CONCLUSION OF LAW

Based on the testimony and evidence presented, the Task Force finds the testimony of Mr. Eisenberg to be persuasive and finds Administrative Code (Sunshine Ordinance), Sections 67.21(b), 67.24(a)(e), 67.25(a), 67.26, and 67.27 to be applicable to this case. The Task Force does not find the testimony provided by Frank Lee, Department of Public Works, persuasive to this case.

DECISION AND ORDER OF DETERMINATIONS


The Task Force finds Edgar Lopez, Paul Travis and Frank Lee, Department of Public Works, in violation of Administrative Code (Sunshine Ordinance), Sections 67.21(b), 67.24(a)(e), 67.25(a), 67.26, and 67.27. The Department of Public Works is ordered to provide all documents that have been withheld, including but not limited to documents originally requested by Mr. Eisenberg, communications among city employees and third parties, written notes and other records regarding the project at 2111-2115 Jennings Street within 5 business days. The Department of Public Works is further ordered to appear at the Compliance and Amendments Committee to report on the status of compliance with this Order of Determination.
