CONSENT AGENDA – Items 8 and 9

The Sunshine Ordinance Task Force shall review **File Nos. 25021 and 25041** to affirm the Committee's findings regarding the Sunshine Ordinance Task Force's jurisdiction; violations of the Sunshine Ordinance, Brown Act, or California Public Records Act; and, if applicable, to issue an Order of Determination and refer matters to a Committee for monitoring. The Complainant and Respondent are *not required to attend the July 2, 2025 Sunshine Ordinance Task Force meeting* but may attend to provide testimony during the public comment period for this item related to the determinations listed below. *(Discussion and Action)*

8. **File No. 25021:** Complaint filed by Stacy Smith against the San Francisco Public Library, San Francisco Police Department, and 911 Communications for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21 by failing to respond to a public records request in a timely and/or complete manner. *(attachments)*

(On 6/17/2025, the Complaint Committee found that the Task Force has jurisdiction, that the requested records are public, and referred the matter to the Task Force Consent Agenda with a finding of no violation by the San Francisco Public Library, and a finding that the San Francisco Police Department violated Administrative Code (Sunshine Ordinance) Section 67.21 by failing to respond to a public records request received in December 2024 and responded to in April 2025. The Committee finds no violation by 911 Communications/DEM and further recommends that Petitioner follow up with the Police Department and DEM regarding records requests.)

9. **File No. 25041:** Complaint filed by Anmarie against Paria Dea and the Fine Arts Museums of San Francisco for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.5, for failing to hold open and public meetings, 67.10(b) for meeting in closed session on a non-permitted topic, and 67.11 for failing to state the statutory authority for the closed session. *(attachments)*

(On 6/17/2025, the Complaint Committee voted to place File 25041 on the Task Force Consent Calendar by stipulation of the parties that the Task Force consider finding that Respondents violated Administrative Code (Sunshine Ordinance), Section(s) 67.5 for failure to hold open and public meetings, 67.10(b) for meeting in closed session on a non-permitted topic, and 67.11 for failing to state the statutory authority for the closed session.)

On 10/31/2024, Mr. Kniha notified the Task Force that 5 business days had passed, and he had not received any documents from the SFMTA.

On 4/22/2025, File Nos. 23020 and 23036 were called and heard together by the Compliance and Amendments Committee, who referred the matters to the full Task Force saying that Respondent had not produced the records or appeared before the Compliance and Amendments Committee.)

Public Comment will be taken before or during the Committee's consideration of each agenda item. Speakers may address the Task Force for up to three minutes on that item. Any person speaking during a public comment period may supply a brief written summary of their comments, which shall, if no more than 150 words, be included in the official file.

Each member of the public will be allotted the same maximum number of minutes to speak as set by the Chair at the beginning of each item, excluding persons requested by the Task Force to make presentations, except that public speakers using interpretation assistance will be allowed to testify for twice the amount of the public testimony time limit. If simultaneous interpretation services are used, speakers will be governed by the public testimony time limit applied to speakers not requesting interpretation assistance.

Each member of the public who is unable to attend the public meeting or hearing may submit to the City, by the time the hearing begins, written comments regarding the agenda items. Under Campaign and Governmental Conduct Code, Section 1.127, no person or entity with a financial interest in a land use matter pending before the Board of Appeals, Board of Supervisors, Building Inspection Commission, Commission on Community Investment and Infrastructure, Historic Preservation Commission, Planning Commission, Port Commission, or the Treasure Island Development Authority Board of Directors, may make a campaign contribution to a member of the Board of Supervisors, the Mayor, the City Attorney, or a candidate for any of those offices, from the date the land use matter commenced until 12 months after the board or commission has made a final decision, or any appeal to another City agency from that decision has been resolved.
