Re: Complaint # 07057 filed by Jeff Ente against Supervisor Aaron Peskin for alleged incomplete production of documents.

Based on the information provided to the Task Force from complainant Jeff Ente and public comment, the following Order of Determination is adopted:

The Sunshine Ordinance Task Force finds that Supervisor Aaron Peskin violated Sections 67.21, 67.21e, 67.29-1, and 67.29-7 of the Sunshine Ordinance for failure to provide the requested records and failure to maintain records according to document retention schedules and in a professional and businesslike manner.

The Task Force is requesting that representatives from Supervisor Aaron Peskin's Office, the Department of Telecommunications and Information Services and the I.T. Manager for the Board of Supervisors to appear before the Compliance and Amendment Committee to speak on the issue on whether and how the Supervisor's email is backed-up, archived and/or retrievable.

Mr. Llorente-

Thank you for your help on the SOTF complaint that I filed (#07057) that was heard by the full Task Force Tuesday evening.

I have some questions about the jurisdiction of the SOTF that I'd like to ask you about in person if you have perhaps 20 minutes some time over the next few days (but hopefully well in advance of the 9/12 Compliance Committee meeting). For several reasons I am wondering if it would be beneficial for me to amend my complaint or to file additional complaints so that the original can go forward without disruption. I have questions surrounding three main areas:

- 1) The issue has become complicated as the Task Force has charged Mr. Peskin with violations that I didn't include in my complaint (67.21-E)
- 2) I believe that the documents I am requesting have been in the possession of more than one Supervisor. For example Supervisor Dufty indicated in an email that he had read them.
- 3) I have information that I did not present to the Task Force because I am uncertain of its jurisdictional relevance and did not want to burden the SOTF unnecessarily due to my ignorance. I do feel that it is important information and would like your opinion as to it's relevance. I'm not asking for nor do I expect any confidentiality on this information.

Task Force-

Thank you for your attention to complaint #07057. I wanted to offer some thoughts that I believe will assist the email retrieval process requested by the Compliance Committee concerning emails that Supervisor Peskin may have deleted that were relevant to my complaint.

- 1) Search terms. Member Craven suggested at one point that the system people search for the word 'parrot' on the email backup server from April 10-June 5. That's a good start but as someone who has spent a lot of time Googling the situation I can tell you that they should do a Boolean search for 'parrots' or 'parakeets' or 'sunflower seeds' or 'forage'. I think the false hits would be minimal with those terms.
- 2) If I understood Mr. Darby correctly the emails remain on the server until they are deleted and that merely reading an email does not remove it from the server. The email server is backed up nightly (anything less would be a horrific example of earthquake unpreparedness). This would suggest that an email would have had to have been delivered, read, deleted and the trash had to be emptied in one business day for there to be no record of the email.
- 3) Supervisor Peskin indicated in the June 5 Board meeting that all of the Supervisors had seen the emails so at least ten copies were likely forwarded through the system, increasing the likelihood that some record of them exists on the backup server.

Thank you again for your assistance on the matter and please contact me if I can assist in the process in any way.

In the above-cited proceeding, the Sunshine Ordinance Task Force issued an Order of Determination on August 28, 2007, that your office had violated Sections 67.21, 67.21(e), 67.29-1 and 67.29-7 of the Ordinance by failing to produce e-mails that Jeff Ente had requested regarding the issue of feeding feral parrots. (The text of these Ordinance provisions are available online at http://www.sfgov.org/site/sunshine_page.asp?id=31022.)

At subsequent meetings of the Task Force's Compliance and Amendments Committee, on September 10 and November 14, 2007, Mr. Ente reported that his request remained unmet.

Your staff aide David Noyola has told the Task Force and the Committee that the e-mails were deleted from your system once the Board and Mayor Gavin Newsom had concluded action on the feeding issue.

Please be informed that failure by your office to meet any of these requests shall result in referral of the matter back to the full Task Force, very likely with the Committee's recommendation that your office be found in willful failure to comply with the aforementioned sections of the Ordinance and that the Task Force request intercedence in the matter by the City Ethics Commission, the District Attorney and/or the California Attorney General.

Please be informed that the Sunshine Ordinance Task Force Compliance and Amendments Committee has sent the above-cited matter back to the full Task Force, which will consider referring the matter to the City Ethics Commission, the District Attorney and/or the State Attorney General for investigation and possible disciplinary action.

The Committee's action, taken at its regular meeting on December 12, 2007, stemmed from the failure of your office to comply with the Task Force's Order of Determination of August 28, 2007, which declared a finding of violations of Sections 67.21, 67.21(e), 67.29-1 and 67.29-7 of the Sunshine Ordinance. (The text of these Ordinance provisions are available online at http://www.sfgov.org/site/sunshine_page.asp?id=31022.)

Please recall that (1) the Order of Determination resulted from the failure of your office to satisfy Jeff Ente's request for copies of e-mails sent or received by your office regarding a proposal to ban feeding of feral parrots; and (2) following issuance of the Order of Determination, the Committee asked you to enlist the assistance of the City Department of Telecommunications and Information Services (DTIS) in an effort to retrieve those e-mails, which, according to your staff aide David Noyola, had been deleted from your system once the Board of Supervisors and Mayor Gavin Newsom had concluded action on the proposed ban.

The Task Force is due to take the matter up at a special meeting on Tuesday, January 8, 2008, and is interested in knowing (a) what measure(s) the DTIS took toward retrieving

the deleted e-mails; (b) whether these measures were successful; and (c) if these measures were successful, have copies of the e-mails been provided to Jeff Ente.

You and/or a representative of your office who is knowledgeable about this matter are requested to attend the meeting, per Sunshine Ordinance Section 67.21(e), which states in part: "[T]he Sunshine (Ordinance) Task Force may consuct a public hearing concerning the records request denial. An authorized representative of the custodian of the public records requested shall attend any hearing and explain the basis for its decision to withhold the records requested."
