I am responding to the above referenced complaint on behalf of the Police Department's Community Relations Unit as received on March 29, 2011.

The LGBT Community Forum referenced in this complaint is a passive meeting body within the meaning of the San Francisco Administrative Code, §67.3(c)(1) and 67.4(a)(5). This particular forum and several similar community forums were organized by the San Francisco Police Department's Community Relations Unit under the direction of the Chief of Police who is the Department head.

As a passive meeting body, there is no requirement to provide opportunities for comment by members of the public at such meetings. (Admin Code §67.4.(a)(3))

Consequently, the alleged violation did not occur and therefore no basis for the complaint exists.
