Complainant Dorian Maxwell presented the Task Force with a status report. The SF Municipal Transportation Agency was not represented.

Member Washburn, seconded by Member Johnson, motioned to refer SFMTA Employee Labor Relations Manager Rumi Uno to the Ethics Commission for violating Section 67.34 for willful failure to comply with the Order of Determination, Section 67.25 by failing to respond in a timely manner, Section 67.26 for not keeping withholding to a minimum, Section 67.27 for failing to provide justification for withholding and California Public Records Act 6254(c) because Mr. Maxwell's was asking for his own personnel file and therefore could not have invaded his privacy..

**Public Comment:** Kimo Crossman said violation of Sec. 67.34 was crucial if the Task Force wanted reaction from the Ethics Commission. David Pilpel said the motion does not match the description on the agenda. Tomas Picarello said the availability of detailed minutes would have helped in this complex case.

Member Washburn, seconded by Member Johnson, motioned to amend her motion to include a violation of Section 67.34 for willful failure to comply with the Order of Determination.

Without objection and on the advice of DCA Threet, Chair Knee, declared the matter, for procedural reasons and in order to comply with the Sunshine Ordinance and the Brown Act, continued to the next regular scheduled meeting on April 26, 2011.

Member Washburn, seconded by Member Costa, motioned to continue David Hill's Ethics Commission referral to the next regular scheduled meeting on April 26, 2011.
