On June 5, 2024, the Sunshine Ordinance Task Force moved to refer File No. 23053 to the June Compliance and Amendments Committee agenda to investigate consolidation and closure.)

(On April 23, 2024, the Complaint Committee moved to find that the Sunshine Ordinance Task Force ("SOTF") has jurisdiction over the matter, that the requested records are public, and refer the matter to full Task Force Consent Agenda with a recommendation to find that the Department of Public Health ("DPH") violated Administrative Code, Section(s) 67.21(c) for inadequate efforts to assist the Complainant in refining their search for public records. The Committee requested that there be an order that the Department of Public Health document the location and produced documents that are responsive, and that the response and refinement process be reviewed by the Compliance and Amendments Committee ("CAC"). The CAC will review the efforts by the parties to determine a searchable refined list of DPH employees who served as point

persons involved in the encampment resolution regarding COVID. The Committee further recommends that the matter be referred to the Compliance and Amendments Committee to monitor compliance with the Committee's request to provide documentation of the located and produced documents that are responsive. On June 5, 2024, the SOTF moved to refer File No. 23053 to the Compliance and Amendments Committee June 25, 2024 agenda to investigate consolidation and closure.)

#### **Meeting Procedures**

Public Comment will be taken before or during the Committee's consideration of each agenda item. Speakers may address the Task Force for up to three minutes on that item. During General Public Comment, members of the public may address the Task Force on matters that are within the Task Force's jurisdiction and are not on the agenda. Any person speaking during a public comment period may supply a brief written summary of their comments, which shall, if no more than 150 words, be included in the official file.

Each member of the public will be allotted the same maximum number of minutes to speak as set by the Chair at the beginning of each item, excluding persons requested by the Task Force to make presentations, except that public speakers using interpretation assistance will be allowed to testify for twice the amount of the public testimony time limit. If simultaneous interpretation services are used, speakers will be governed by the public testimony time limit applied to speakers not requesting interpretation assistance.

Each member of the public who is unable to attend the public meeting or hearing may submit to the City, by the time the hearing begins, written comments regarding the agenda items. These comments will be made a part of the official public record. Written communications should be submitted to the SOTF at:

Under Campaign and Governmental Conduct Code, Section 1.127, no person or entity with a financial interest in a land use matter pending before the Board of Appeals, Board of Supervisors, Building Inspection Commission, Commission on Community Investment and Infrastructure, Historic Preservation Commission, Planning Commission, Port Commission, or the Treasure Island Development Authority Board of Directors, may make a campaign contribution to a member of the Board of Supervisors, the Mayor, the City Attorney, or a candidate for any of those offices, from the date the land use matter commenced until 12 months after the board or commission has made a final decision, or any appeal to another City agency from that decision has been resolved.
