### 1. CALL TO ORDER, ROLL CALL, AND AGENDA CHANGES.

Chair Yankee called the meeting to order at 4:04 p.m. On the call of the roll, Chair Yankee, Vice-Chair Stein, and Members Schmidt, Anderson, Sugarman, Pilpel and Hyland were noted present. Member Wolfe appeared remotely. Members LaHood and Kumar were noted absent. Deputy City Attorney Valerie Lopez was present. A quorum was present.

The Task Force discussed changing the order of the cases as requested by Respondent Margot Shaub and Complainant Wynship Hillier.

### Public Comment:

Peter Warfield, Executive Director, Library Users Association, libraryusers2004@yahoo.com, P.O. Box 170544, San Francisco, California, 94117-0544 stated that the number of materials posted on the agenda were larger than he expected and that he did not have adequate time to prepare his case and asked that his complaint be pushed back from the agenda.

2. Approval of the minutes from the Sunshine Ordinance Task Force Meeting of March 6, 2024. (11.35)

Peter Warfield agreed with continuing approval of the March 6, 2024 Task Force minutes until the May 1, 2024 hearing.

Mark Sullivan provided the following written public comment:

"There are 6 provisions between the Sunshine Ordinance and The Brown Act that deal with the requirements of documents in an agenda item. Sec. 67.7. Agenda Requirements; Regular Meetings. (b)... 'It shall refer to any explanatory documents that have been provided to the policy body in connection with an agenda item, such as correspondence or reports, and such documents shall be posted adjacent to the agenda or, if such documents are of more than one page in length, made available for public inspection and copying at a location indicated on the agenda during normal office hours.' This means that revision documents submitted should be included in approval of the minutes agenda item."

Peter Warfield suggested that more clarity be provided on the agenda so that members of the public have an idea when explaining the circumstances.

Mark Sullivan provided the following written public comment:

"Yankee and Stein went to Young with concerns about a supposed grey area complaint. Schmidt asked if happened often; was new procedure. Young is different department has no right to insert himself into how the Sunshine Ordinance is interpreted unless he is speaking during the time frame of speaking on behalf of the respondent during a hearing. He was speaking on behalf of the city to narrow transparency not in the public's interest. Allow Clerks speak meeting protocol questions. If a clerk wishes to speak about complaint, it should be in the time frame of speaking for a party in a complaint or during the 3-minute comment, other department employees. Task Force legal counsel is ethically walled off from the city and SOTF did not go to them with a supposed gray area of concern. Mr. Young is not legal counsel, not ethically walled off. Throw out determination on complaint 23098."

# 5. **File No. 23097 - Proposed Revisions to the Complaint Procedures and By-Laws:** Potentially adopt proposed revisions to the SOTF Complaint Procedures to expedite complaint processing per the Sunshine Ordinance requirements, and present and discuss related proposed changes to the SOTF By-Laws. (52.00)

Members Schmidt and Pilpel presented the proposed edits in the Complaint Procedures to the Task Force.

Action: Moved by Member Schmidt, seconded by Member Pilpel, to approve the proposed new language to the Complaint Procedures as amended.

Public Comment:

Mark Sullivan provided the following written public comment:

"CA Constitution, Article 1, Section 3 (2) "statute, court rule, or other authority", which means the task force's bylaws and complaint procedures as you are written in the Ordinance and how you function are essential to the application of the Ordinance... 'shall be broadly construed if it furthers the people's right of access, narrowly construed if it limits the right of access.' Courts consistently stated records are presumed public until exemption is invoked by custodian/ agency. Look to see if the department has claimed an exemption, if not the records are public. Complaint procedure language should require respondents to make clear exemption and if none claimed, respondent is not granted a hearing. Records are de facto public. Record pivots on an exemption claimed. CPRA clearer language regarding exemptions/public records. Most complaints violations of time. More action by the task force assisting people's right of access to records in time."

Peter Warfield noted that he was not able to follow closely with the changes and it is good that the Task Force is looking to satisfy the 45-day statutory requirement that has been in place for decades but not often satisfied.

6. **Public Comment:** Members of the public may address the Sunshine Ordinance Task Force (SOTF) on matters that are within SOTF's jurisdiction, but not on today's agenda. *Public comment shall be taken at 5:00 p.m. or as soon thereafter as possible.* (1.55)

Mark Sullivan provided the following written Public Comment:

"SOTF's ability to remedy violations has been seriously compromised as a result of the City Attorney's advice. Voting "rule" is manifestly unfair cannot be justified under any appropriate standard. Contrary to purposes of constitutional and state law protections for gaining access to public meetings and records. The current SOTF voting procedure whether a requested record is disclosable should be reversed because under California law all public records are presumptively disclosable; the City's departments, officials and policy bodies have the burden of establishing that a specific exemption from disclosure applies. For that reason, a motion should not be for a determination of a "violation." Rather, the motion put to the vote should be for a determination that the specific exemption relied on by the respondent applies; and the burden of proving that exemption should rest on the respondent, not on the complainant, to establish that it does not apply."

Chris Ward Kline commented on the discussion regarding timing, that the City Attorney's Office is aware that Task Force meetings should not take this long and that everyone is doing their best.

Peter Warfield stated that he wanted to provide a presentation to the Task Force and requested to see the number of drafts presented by Ms. Leger to the Library's response.

7. **File No. 23013(C)**: **Reconsideration of Complaint:** Complaint filed by Chris Ward Kline against the Mayor's Office for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, 67.24(b), and 67.25, by failing to respond to a request for public records in a timely and/or complete manner. (2.06)

Chris Ward Kline (Petitioner) provided a summary of the complaints and requested the Task Force to find violations. Mr. Kline suggested that the Mayor's Office consider emails as audio files which are used to collect data. Mr. Kline stated that the Mayor's Office and Mr. Heckel have told him that there are no files to turn over. Mr. Kline believes that the Mayor's Office has collected his health information and used it against Mr. Kline.

Hank Heckel (Mayor's Office, Respondent) provided a summary of the department's position. Mr. Heckel stated that the Mayor's Office has received many requests for surveillance technology records from Mr. Kline. Mr. Heckel stated that the Mayor's Office does not use surveillance technology.

Action: Moved by Member Pilpel, seconded by Member Hyland, to deny the request for reconsideration.

- 8. **A File No. 22027: Hearing on the status of the Order of Determination:** Complaint filed by John Templeton against the Planning Department for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.7; 67.21, and 67.29-7, by failing to post an agenda containing a meaningful description of each item of business to be transacted or discussed at the meeting; failing to responded to a request for public records in a timely and/or complete manner; and failing to maintain and preserve all documents is a professional manner. (2.47)
  - **B. File No. 22028**: **Hearing on the status of the Order of Determination**: Complaint filed by John Templeton against the Historic Preservation Commission for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.7, 67.21, and 67.29-7, by failing to post an agenda containing a meaningful description of each item of business

to be transacted or discussed at the meeting; failing to respond to a request for public records in a timely and/or complete manner; and failing to maintain and preserve all documents is a professional manner.

The Task Force heard File Nos. 22027 and 22028 together.

Mr. Templeton (Petitioner) provided a summary of the complaints and requested that the Task Force find violations. Mr. Templeton stated he requested the signed May 1 grant agreement from the Planning Department and was not provided. Mr. Templeton requested those same records from the Mayor's Office and received them within one day. Mr. Templeton stated that after receiving the Order of Determination from the Task Force in 2007 filed a claim with the California Civil Rights Department against the Planning Department due to racial prejudice within that department and that he never received his requested records from them.

Jonas Ionin (Respondent, Planning Department and Historic Preservation Commission) provided a summary of the department's position. Mr. Ionin stated that his understanding is Mr. Templeton requested the May 1 grant agreement signed by Richard Hillis and Reverand Edgar Boyd of the Economic Development Office in 2008. Mr. Ionin stated that the Petitioner needed to be more specific regarding which records they are looking for. Mr. Ionin noted that his office completed their due diligence.

Action: Moved by Chair Yankee, seconded by Member Anderson, to close File Nos. 22027 and 22028 without prejudice.

Peter Warfield stated he understood that this case was about civil rights and that people have rights which should be respected regardless of what their purposes are.

(3.30)

Peter Warfield (Petitioner) provided a summary of the complaints and requested the Task Force to find violations. Mr. Warfield stated this his case is about access to information requested in an Immediate Disclosure Request to the Public Library. Mr. Warfield stated he requested access to the Library Offices to look at public information regarding the Night of Ideas.

Margot Shaub (Public Library, Respondent) provided a summary of the department's position. Ms. Shaub stated that Mr. Warfield arrived at the Library Offices after 5:00 p.m. and that he knows that the offices close at that time. Ms. Shaub stated that she asked Mr. Warfield to return in 15 minutes for his records and he said he could not wait 15 minutes. Ms. Shaub stated that she would have provided the information to Mr. Warfield if he provided the time to comply.
