4. **File No. 23100:** Complaint filed by Jimmer Cassiol against the City Administrator's Office for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21 by failing to respond to a public records request in a timely and/or complete manner. (00:09:36)

Jimmer Cassiol (Complainant) stated that the City Administrator's Office has denied his request for records citing privacy reasons, but his request is for communications between the manager and Human Resources that pertain to him; they should not be considered personnel records.

Vivian Po, City Administrator's Office (Respondent) stated that Mr. Cassiol's request was reviewed again in consultation with the City Attorney and their Human Resources team, and it was determined that the requested documents are considered personnel records. Ms. Po further stated that a reply was provided to Mr. Cassiol with legal citations for withholding records and emphasized that the request was being treated like any other request that came from the public.

Moved by Member Wolfe, seconded by Member Anderson, to continue the matter to the call of the Chair.
