Patrick Monette-Shaw (Petitioner) provided a summary of the complaint and requested the Committee to find violations. Mr. Monette-Shaw stated that the remote access code was incorrect on the agenda and remote public comment could not be made.

Victor Lim, Department of Public Health (Respondent) provided a summary of the department's position. Mr. Lim acknowledged that there was a clerical error made on the agenda for the September 8, 2025 meeting and that correct login information was posted in an attempt to correct the information. Steps have since been taken to prevent the problem occurring in the future. Mr. Lim requested dismissal of the complaint.

Chikodi Chima (Petitioner) provided a summary of the complaint and requested the Committee to find violations. Mr.. Chima submitted the request via email but the request was denied.

Michelle Berry, Human Services Agency (Respondent) provided a summary of the department's position. Ms. Berry stated the request was responded to in a timely manner and the requested records are confidential pursuant to California Welfare Institution Code, Section 10850. Ms. Berry stated that they cannot confirm or deny the existence of records without a court order. Ms. Berry stated that payroll payments in question are made by the state and not the City and County of San Francisco. Ms. Berry stated that all other relevant information regarding the issue was provided.
