The members discussed the role of journalists on the Task Force for transparency in government, their support for continuing the current process for selecting the membership, and the importance of retaining the disabled and Society of Professional Journalist seats. The members further discussed the classification of the Task Force, whether it is regulatory or advisory, and that it is a compliance body.

Public Comment: Aaron Wilson stated that the Task Force is important as a regulating body with the ability to issue orders and hopefully have them complied with by the departments. Mr. Wilson further stated that the body needs to be made up of the types of people who are on the Task Force now and that a 12-year term is enough.

8. **File No. 25080 (25-6968):** Complaint filed by Aaron Wilson against San Francisco Animal Care & Control for allegedly violating Administrative Code (Sunshine Ordinance), Section 67.26, by failing to keep withholdings to a minimum, and Section 67.27, by failing to provide written justification of withholdings. DCA Valerie Lopez stated that with all members of the Complaint Committee present, the item was agendized correctly and could proceed before the Task Force.

## **COMPLAINT HEARING AGENDA – *Items 9 through 11***

9. **File No. 25063:** Complaint filed by Hanley Chan against the Department of Technology for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.25 by failing to respond by failing to respond to an immediate disclosure request in a timely and/or complete manner. (01:47:27)

*(On 10/15/2025, the Task Force found that it has jurisdiction in the matter and found that the Department of Technology violated Administrative Code (Sunshine Ordinance), Section 67.25, by failing to respond to an immediate disclosure request in a timely and/or complete manner. The Respondent is to provide a written response by 11/19/2025 explaining why the department feels it is neither the custodian nor in custody of the requested records as described by the Sunshine Ordinance.)*

Hanley Chan (Petitioner) was not present.

Karen Hong, Chief of Staff and Custodian of Records (Respondent) requested a reconsideration of the Administrative Code (Sunshine Ordinance), Section 67.25, violation based on new findings, and stated that the supporting documents have been provided from the Committee on Information Technology which defines the roles that the department has in terms of data, which is that the department is the holder of the email records that are responsive to a request.

A question-and-answer period occurred.

**Action: Moved by Member Schmidt, seconded by Vice-Chair Stein, to find that the Department of Technology violated Administrative Code (Sunshine Ordinance), Section(s) 67.25 by failing to respond to in immediate disclosure request in a timely and/or complete manner. The Task Force further ordered the production of the requested records per Section(s) 67.21 and referred the matter to a Committee for follow-up.**

Public Comment: Aaron Wilson stated that he believes that the Department of Technology's policy is a workaround of the Sunshine Ordinance and that if this is allowed to occur then transparency is compromised.

10. **File No. 25033:** Joudere Gaines against the San Francisco Municipal Transportation Agency for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to respond to a public records request in a timely and/or complete manner. (02:44:40)

*(On 9/23/2025, the Education, Outreach, and Training Committee continued and forwarded the matter to the Complaint Committee and asked that the San Francisco Municipal Transportation Agency provide a point-by-point response to each of the requested listed in NR-24-6646 located on pages 3-8 of the meeting packet.)*

*(On 11/18/2025, the Complaint Committee found that the Task Force has jurisdiction, that the requested records are public, and referred the matter to the full Task Force with no recommendation.)*

Joudere Gaines (Petitioner) was not present.

Scott Edwards (Respondent) was present.

**Action: Moved by Chair Yankee, seconded by Member Schmidt, to close File No. 25033 per Sunshine Ordinance Task Force Complaint Procedure, Section C(7)(b).**

Public Comment: Aaron Wilson stated that Petitioner should have respect for the Task Force and missed out on an opportunity to participate in San Francisco government.

11. **File No. 25075:** Complaint filed by Jared Stratton against the San Francisco Police Department for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to respond to a public records request in a timely and/or complete manner. (02:49:50)

*(On 11/18/2025, the Complaint Committee found that the Task Force has jurisdiction, that the requested records are public, and referred the matter to the full Task Force with no recommendation.)*

Member Hyland was noted absent at 7:02 pm.

Jarrod Stratton (Petitioner) presented his position and stated that the public interest outweighs whatever is in the file.

Lt. William Heppler (Respondent) provided an overview of the case and stated that on 9/12/2025 Petitioner was informed that his request was denied due to the open case investigation exemption per Gov. Code Section 7923.660, and that this case remains an open investigation and disclosure of the requested information would endanger the successful completion of the investigation and/or adjudication. Lt. Heppler further stated that a second similar request received 9/28/2025 was also denied. Lt. Heppler stated that he spoke with Homicide detail and confirmed that the case is active and that no parts could be released at this time and were withheld correctly per Section 7923.660, and that he consulted with their Deputy City Attorney to confirm that that Section 67.24(d) has been complied with.

A question-and-answer period occurred.

The parties provided rebuttals.

**Action: Moved by Chair Yankee, seconded by Wolfe, to continue the matter to the January 7, 2026 Regular Meeting of the Sunshine Ordinance Task Force meeting. The Task Force further ordered the San Francisco Police Department to review the April 17, 2025 flowchart developed by Lt. Ozol re File No. 23086 for reviewing an “open/active investigation” and provide a written response to the Task Force with the results of applying the flowchart and California Senate Bill 16 (2021) to the review of this file.**

Public Comment: Aaron Wilson stated that it's good that the Task Force is trying to get to the bottom of these types of cases and that public officials who attempt to conduct the public's business in secret should be held accountable.
