ORDER OF DETERMINATION

DATE DECISION ISSUED: 9/3/2025

File No. 25048: Complaint filed by Mark Sullivan against David Steinberg and San Francisco Public Works for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21(b), for failing to respond in a timely and/or complete manner, Section 67.21(l), for failing to provide public information for inspection and copying, Section 67.26, for failing to keep the withholding of records without justification to a minimum, and Section 67.27, for failing to provide a justification for withholding records.
