Dear Honorable Members of the Sunshine Ordinance Task Force:

We write in response to Complaint No. 22139 (Complaint) filed by an anonymous requester (Complainant) on October 6, 2022 with the Sunshine Ordinance Task Force (Task Force). The Task Force sent the Complaint to the San Francisco Public Utilities Commission on November 17, 2022.

The Complaint pertains to the Complainant's public records request received by the SFPUC on September 11, 2022, which sought:

communications (emails, texts, chats, etc.) sent or received in the last 6 months between or among: Dennis Herrera, Ron Flynn, John Cote, Michael Carlin, Scarpulla, and/or PUC records-specific staff, discussing or planning response or strategy to or for ANY SUNSHINE REQUEST OR COMPLAINT OR SUNSHINE LAW IN GENERAL. Produce rolling basis, starting with most recent to least recent.

In response to this request, the SFPUC produced a number of records on a rolling basis on September 14, September 20, September 23, September 26, and September 27, 2022. The SFPUC redacted portions of those records based on attorney-client privilege (Government Code Section 6254(k) and Evidence Code Section 954), attorney work product (Cal. Gov't Code § 6276.04), privacy (California Constitution, Article I, section 1, and Government Code Section 6254(c)), and confidential vendor information (Government Code Section 6254.33). The SFPUC withheld additional documents based on attorney-client privilege.

**Contention:** The Complainant alleges that SFPUC "stated attorney client privilege of communications where the parties are not attorneys and redacted those words. And worse, They [*sic*] even say Mayara Sa's email to John Scarpulla on April 20, 2022 is attorney work product privilege but Sa is not a valid attorney as of Feb 2021:

**Response:** The records produced to the Complainant contained privileged and confidential communications between SFPUC and the San Francisco City Attorney's Office. As such, portions of the records produced to the Complainant are exempt from disclosure pursuant to Government Code section 6254(k) (which exempts records protected from disclosure under federal or state law, including provisions of the Evidence Code relating to privilege) and Evidence Code section 954 (enshrining the privilege for communications between attorneys and their clients). The records in question remain privileged and confidential.

On October 25, 2022, the Supervisor of Records replied to a petition filed by the Complainant that raised allegations identical to those raised in the Complaint. In response to the petition, the Supervisor of Records reviewed the records SFPUC produced to the Complainant, and concluded that the SFPUC appropriately redacted portions of the documents produced to the Complainant.<sup>1</sup> See attached Exhibits A and B. The Supervisor of Records' review included the email between Mayara Sa and John Scarpulla that is referred to in the Complaint, and agreed that the redacted portions of that email reflected attorney-client communications and privileged advice provided by the City Attorney's Office to the SFPUC.

Disclosure of the redacted portions of the records the Complainant seeks would compromise the privilege protecting the legal advice the City Attorney's Office has provided to the SFPUC. The SFPUC has appropriately redacted the records produced to the Complainant to preserve the privilege in these communications. Based on the foregoing, SFPUC respectfully requests that Complaint No. 22139 be dismissed.

This letter responds to your petition sent via email to the Supervisor of Records on September 27, 2022, concerning your September 11, 2022 request to the San Francisco Public Utilities Commission ("SFPUC"). In your September 11 email, you requested the following records:

communications (emails, texts, chats, etc.) sent or received in the last 6 months between or among: Dennis Herrera, Ron Flynn, John Cote, Michael Carlin, Scarpulla, and/or PUC records-specific staff, discussing or planning response or strategy to or for ANY SUNSHINE REQUESTOR COMPLAINT OR SUNSHINE LAW IN GENERAL.

In response to your request, the SFPUC provided you a number of records on a rolling basis on September 14, September 20, September 23, September 26, and September 27, 2022. The SFPUC redacted portions of those records based on attorney-client privilege (California Government Code Section 6254(k) and California Evidence Code Section 954), attorney work product (California Government Code § 6276.04), personal privacy (California Constitution, Article I, section 1, and California Government Code Section 6254(c)), and confidential vendor or contractor information (Government Code Section 6254.33).

In your petition to the Supervisor of Records, you requested that we review the records, and you specifically questioned whether the SFPUC appropriately redacted portions of the text based on attorney-client privilege. On October 19, 2022, after you submitted the petition, the SFPUC produced one of the previously-disclosed records with modified redactions. In the SFPUC's initial production, the agency had redacted a portion of that record based on attorney-client privilege, but the agency made a correction in the revised production on October 19, stating that it was withholding a portion of the record as a confidential personnel record under Government Code Section 6254(c).

After reviewing the records, including the corrected record that the SFPUC produced on October 19, we conclude that the SFPUC appropriately redacted portions of the documents produced to you. In your petition, you noted that the SFPUC relied on attorney-client privilege to redact portions of emails between SFPUC staff that did not include direct communications with any attorneys. The redacted portions of those emails reflected attorney-client communications and privileged advice provided by the City Attorney's Office to the SFPUC. Disclosure of the redacted portions would have disclosed the attorney-client privileged
