The San Francisco Police Department (SFPD) is in receipt of the Complaint filed by Rosa L. with the Sunshine Ordinance Task Force (SOTF) alleging that SFPD violated Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to respond to a records request in a timely and/or complete manner.

SFPD received Complainant's public records request, dated July 9, 2023, at approximately 10:03 PM and a confirmation message was sent to the customer. On July 9, 2023, a member of the SFPD Media Relations, Sgt. Adam Lobsinger, was assigned the request at approximately 6:48 AM. On August 24, 2023, the request was assigned to a different member of the Media Relations Unit, Sgt. Kathryn Winters, due to staffing changes. On January 9, 2024, I, Officer Rueca was assigned the request

SFPD takes responsibility for not providing a timely response, within the 10-day period pursuant to California Government Code section 7922.535(a). Due to staffing limitations, staffing changes, and a pending lawsuit related to this event, as of August 13, 2024, the request is still in progress.

On July 31, 2024, emails were sent to SFPD Fiscal team and SFPD Technology teams to query for responsive records. SFPD Fiscal CFO Kimmie Wu and SFPD Technology Johann Leung and Alvin Tong who conducted searches for responsive records. The SFPD Fiscal team was not able to locate responsive records. Media Relations is searching for additional information to assist in the search of responsive documents regarding the overtime cost that SFPD Fiscal can search further into this matter. SFPD did not withhold any located responsive documents prior to the filing of the complaint.

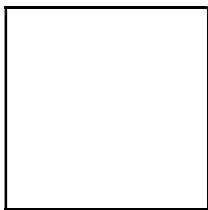

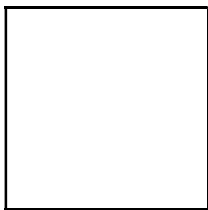
