Dear Department of Building Inspection,

Pursuant to my rights under the San Francisco Sunshine Act (San Francisco Administrative Code Section 67.1) and California Public Records Act (Government Code Section 6250 et seq.), I ask to obtain a copy of the following, which I believe to be held by your agency:

1. The name and email address of the complainant in DBI Complaint No. 202295475 (1754 Leavenworth St.)
2. The name and email address of the complainant in DBI Complaint No. 202295400 (1754 Leavenworth St.)
3. The name and email address of the complainant in DBI Complaint No. 202295313 (1754 Leavenworth St.)
4. The name and email address of the complainant in DBI Complaint No. 202175096 (1754 Leavenworth St.)

I ask for a determination on this request within ten (10) days of receipt, and an even prompter reply if you can make that determination without having to review the record[s] in question.

Regarding potential exemption from disclosure, I would like to bring up the fact that DBI has already released this information to a reporter from the San Francisco Chronicle, Roland Li. (See <https://www.sfchronicle.com/realestate/article/Alison-Collins-and-her-husband-list-S-F-home-for-17425922.php>, "The identity of the author of the complaint was never revealed, but in an email to The Chronicle last fall, the author said he or she wished to remain anonymous to avoid retaliation from Alison Collins. The city confirmed that the person's email address matched the original complaint.")

Further, S.F. Administrative Code § 67.24(d) mandates the disclosure under the Sunshine Ordinance of criminal "[r]ecords pertaining to any investigation, arrest, or other law enforcement activity . . . once the District Attorney or court determines that a prosecution will not be sought . . ." While the records sought here certainly do not pertain to a criminal investigation, this code section is presented for sake of

comparison, as the Sunshine Ordinance mandates release of information that is typically held in much closer confidence than the complainant in a code enforcement complaint.

If you determine that any or all of the information qualifies for an exemption from disclosure, I ask you to note whether, as is normally the case under the Act, the exemption is discretionary, and if so whether it is necessary in this case to exercise your discretion to withhold the information.

If you determine that some but not all of the information is exempt from disclosure and that you intend to withhold it, I ask that you redact it for the time being and make the rest available as requested.

Please provide a signed notification citing the legal authorities on which you rely if you determine that any or all of the information is exempt and will not be disclosed.

If I can provide any clarification that will help expedite your attention to my request, please contact me at 415-309-2908 or carnitasbandit@proton.me. I ask that you notify me of any duplication costs exceeding \$500.00 before you duplicate the records so that I may decide which records I want copied.

I am sending a copy of this letter to the San Francisco City Attorney to help encourage a speedy determination, and I would likewise be happy to discuss my request with them at any time.

RE: Response to File No. 22117

I deny the allegations in made in File No. 22117. The Department of Building Inspection acknowledged Mr./Mrs. G. Tan's public records request on October 2, 2022 and responded on October 6, 2022 with all of the documents in our possession that were responsive to their request.

The documents provided by the Department of Building Inspection were building code complaints filed against 1754 Leavenworth and we redacted the name and contact information of the complainant, as per our standard practice when responding to public records requests.

There is one issue at play in this complaint:

Whether the Department of Building Inspection is required to provide the name and contact information of a person who filed a complaint on a specific property.

We are not. The Department of Building Inspection is authorized by the California Constitution to redact information to protect privacy.

When responding to public records requests, the Department of Building Inspection consistently redacts the name and contact information of the person who filed building or housing code complaints on specific properties. This information is also redacted on the Complaint Data Sheets posted to our website.

The Department of Building Inspection's authority to protect an individual's privacy by redacting information in response to a public records request comes from California Constitution, Article I, section 1, and California Government Code Sections 6254(k) and 6254(c) (authorizing the withholding of records the disclosure of which would constitute an unwarranted invasion of personal privacy). See, also, California Government Code Section 6250 and Section 67.1(g) of the San Francisco Sunshine Ordinance (S.F. Admin. Code §67.1(g) (legislative findings on the right of individuals to privacy).

In responding to the public records request filed by Mr./Ms. G. Tan, the Department of Building Inspection withheld the complainant's name and contact information, as authorized by the California Government Code and included a statement in the response noting that a portion of the record was redacted for privacy, referencing our authority to redact information to protect privacy, and citing the code sections noted above.

As a rule, the Department of Building Inspection strives for transparency and, to our knowledge, there is no prohibition on providing the name and contact information of a property owner that has received a complaint.

Releasing the property owner's name and contact information does not automatically convey a right to the complainant's name and contact information, as asserted in File No. 22117.

The Department of Building Inspection fully responded to the complainant's public records request and only redacted information that we are legally authorized to withhold.
