5) Business (All Items to Follow Discussion and Possible Action)

A. Review Point In Time Count Numbers

- i) From the point-of-view of the department of Homelessness and Supportive Housing, why does it take six months to compile this data? What is the process?
- ii) What are the other variables besides California housing crisis that affect the homelessness crisis here in San Francisco?
- iii) With respect to the ten percent decrease in youth homelessness, how many people have aged out versus actually exited homelessness? Is this correlated to the increase in adult homelessness?



- iv) Regarding the chronicity of homeless youth, what is the average length of homelessness?
- v) Regarding the youth reflected in the point in time count, how many new youth became homeless?
- vi) Has there been any research done on the youth who have successfully exited homelessness? What is their experience?
- vii) Of the 4,000 people who have successfully exited homelessness, what were the best practices gleaned from this population?
- viii) Is there any research on homeless students in vehicles, or the intersection between homeless youth and vehicular homelessness?

B. Prepare Budget & Finance Committee Presentation for June 6th

- i) Commissioner Quick reviews slides
- ii) HSH has a goal of completing 700 units of permanent supportive housing in the next two fiscal years, according to their most recent budget presentation.
 - (1) If they commit 20 percent of those 700 units that would complete the 2015 TAY housing plan. Currently, the department is not equitably or equally serving the youth or TAY population.
 - (2) Will you commit to a new TAY housing plan?
 - (3) What is the progress on the TAY navigation center?
 - (4) P.I.T. Count: What analysis has been done on the 10 percent decrease in youth homelessness?
 - (5) Coordinated Entry: What are the supports offered to TAY who have been assessed through coordinated entry, especially considering a 6 month wait time? Commissioners are concerned at the reports of youth experiencing trauma caused by the intake procedures.
 - (6) How are you supporting accessibility needs for the homeless population?
 - (7) What is being done for youth who are being shuffled into the adult shelters and experience safety challenges?
