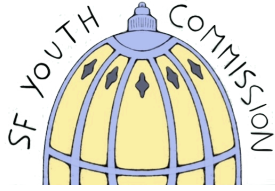

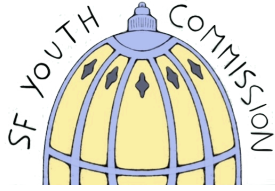

7. Legislation Referred (discussion and action item)

- a. **BOS File No. 240699 - Ordinance - Site for New Library Branch - 100 Orizaba Avenue:** Ordinance requiring that the new Public Library branch serving the Oceanview, Merced Heights, Ingleside, and Lakeview neighborhoods be built on the City-owned parcel of land at 100 Orizaba Avenue (Assessor's Parcel Block No. 7136, Lot No. 060), subject to environmental review, required approvals, and other applicable laws; and prohibiting the expenditure of City funds to explore, pursue, or plan construction of a new Public Library branch serving those neighborhoods at any alternate location, except as required by the environmental review process, required approvals, or other applicable laws.
 - i. Presenter: Jeff Buckley, D11 Legislative Aide



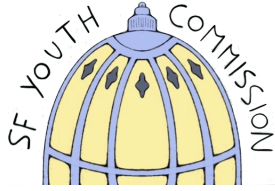
Jeff Buckley spoke on the legislation and the need to approve the legislation with some amendments, and spoke on the upcoming discussion on alternative sites and proposals for the new library in District 11 on Randolph St.

Michael Lamberg, the City's Librarian, thanked Supervisor Safaí for his support for the public libraries, but said that he doesn't agree with his legislation that has been presented by his office. He added that they have a new cost estimate on the proposed library on Orizaba St, which was over \$60-\$90 million when the SFPL has only allocated approximately \$42 million for construction. He added that he does not feel good about supporting any new library in a location with no guaranteed road safety improvements. He asked the Youth Commission to give them four months to continue these deliberations, and to vote in opposition to the Orizaba proposal.

Chair Barker Plummer asked Buckley about the lack of an adequate budget to build it and why it wouldn't work to approve the other site, to which Buckley said the alternate site also has issues criticisms as the original proposed site. Barker Plummer brought up that a housing developer that he knows stated that the Randolph proposal would take significantly shorter to build than the Orizaba proposal, to which Buckley said that the Randolph proposal would also take a long time because they'd have to approve and build a senior center in addition to the public library site.

Lamberg responded by saying that they have been having conversations with the various property owners on how fast the library could be built, and he added that there hasn't been community consensus on the Orizaba proposal. Lamberg also said that he recommends they wait four months until the regional housing bond is voted on to get access to significant funds that would expedite funding for the Randolph proposal.

Officer Fong told Lamberg it seems like the land swap between property owners seems based fully on the housing bond being passed in November and asked what would happen if it didn't pass, to which Lamberg said that they would continue forward with the Orizaba proposal and make it better. Officer Fong asked Buckley how the community process worked for selecting the Orizaba proposal, to which Buckley said it was before his time but that this site met all of the conditions for the public library. Lamberg added that they can move forward with both proposals at the same time, while also waiting for the housing bond in November to pass.



Commissioner Dang asked what the harm of waiting four more months would be since this proposal has been delayed since 2019, to which Buckley said they can always change the legislation if it's advanced, but that D11 constituents have asked for this to be pushed forward.

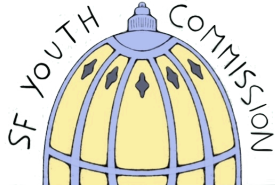
Commissioner Ansari thanked both speakers for wanting to build a library, but that she has concerns about the Orizaba proposal. She added that the church, the library, and the community center are in agreement for the Randolph location, and that it's directly on the M-Oceanview line. She said that she doesn't see the harm in waiting for four months for a potential project that could result in a brand new library, community center, and church that would be great for the community. She also emphasized that they can still push forward with the Orizaba proposal if the regional housing bond does not pass. Commissioner Dang agreed.

The speakers spoke on the details of the property land swap, and clarified some details about how it would move forward with the Randolph proposal. Chair Barker Plummer added that he believes sometimes new information can come up and people can change their minds.

Officer Fong, seconded by Officer Adair, motioned to approve BOS File No. 240699 with a positive recommendation. Discussion: Chair Barker Plummer said that this legislation would take longer based on what information he's obtained. Officer Fong said that there's still a lot of the process that has to happen, and this legislation could move things forward sooner. Officer Adair added that this delay could have an even longer than 4 month delay. Vice Chair Listana supports the Randolph proposal. No public comment. The motion failed by the following roll call vote:

- b. **BOS File No. 240545 - Charter Amendment - Accountability for Funding Children and Youth Services for City Departments and the School District;**



Clarifying Uses of the Student Success Fund: Charter Amendment (Second Draft) to amend the Charter of the City and County of San Francisco to 1) create an Our Children, Our Families Initiative (“Initiative”) to coordinate efforts by City departments and the San Francisco Unified School District (“School District”) to deliver outcomes-based services for children, youth, and families; 2) require the Initiative to use an objective and measurable outcomes framework (“Outcomes Framework”) to evaluate the budget and spending of each City department with expenditures that are eligible to be included in the Children and Youth Fund baseline, the Public Education Enrichment Fund (“PEEF”), the PEEF baseline, or any discretionary funding allocated from the General Fund for children, youth, and families; 3) require the Mayor and Board of Supervisors to consider the Initiative’s findings during their consideration of the City budget each year, including by the Board of Supervisors holding a public hearing and adopting findings about the expenditures; 4) require the School District to submit a proposal once every five years describing how it will spend the City’s general fund contribution to the PEEF consistent with the San Francisco Children and Families Plan and the Outcomes Framework, and prohibit the City from providing PEEF funding to the School District until the Board of Supervisors and Mayor have approved the School District’s proposal; 5) require the School District to submit annual reports describing how it has spent the City’s general fund contribution and the PEEF funding for arts, music, sports, and library programs; 6) authorize the Board of Supervisors and Mayor to place PEEF funding to the School District on reserve if the School District’s expenditures are inconsistent with the Charter, the Outcomes Framework, or the School District’s spending plan or its internal guidelines regarding student educational outcomes; 7) provide that money set aside for the School District in the Student Success Fund cannot replace, supplant, count as, or substitute for other City funding for the School District or children and youth required under the Children and Youth Fund, the PEEF, or other provisions in the Charter; and 8) prohibit the City from providing discretionary funds to the School District unless it has entered into a data-sharing agreement with the City; at an election to be held on November 5, 2024.

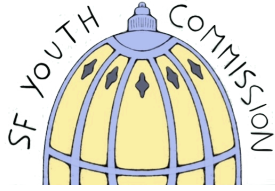

Officer Fong said they worked on notes to push priorities and goals to hand off to the next cohort of the members on the HRT Committee.

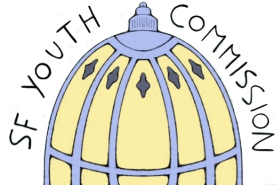
10. Staff Report (discussion item)
