5. Public Comment on matters not on Today's Agenda (2 minutes per comment)

No public comment.

6. Presentation (discussion & possible action)

- a. Budget Presentation San Francisco Unified School District
 - i. Presenter: Dr. Maria Su, Superintendent, and Dr. Michele Huntoon, Associate Superintendent of Business Services

Dr. Maria Su presented the budget for SFUSD's proposed strategic resource allocation, with Dr. Huntoon and BOE Commissioner Ray in attendance.

Commissioner Alameri asked about cuts to the central office and full-time staff and how they will affect classroom sizes, to which Dr. Su said central office staff include a lot of various classifications and there will likely be hard layoffs in the future. She said that the enrollment numbers continue to lower, even with updates for this year, and that they will have to close or merge classrooms.

Commissioner Oram asked that if layoffs are almost inevitable why the district hasn't done a hiring freeze, to which Dr. Su said that there has been a hiring freeze for the past year, which is why they haven't been able to hire counselors that many schools have been asking for.

Commissioner Fortgang asked what steps they're taking to pull families back into public schools, to which Dr. Su said while high school enrollment has been reducing slightly, that there has been a large increase in prekindergarten (TK). She added that the State of California pays the district based on student attendance as well, so she encouraged everyone to make sure their friends go to class. She also said they need to promote more of their unique programs.

Officer Liang asked what the school district is doing to get students to have stronger attendance records, to which Dr. Su said there's many issues that students face that continue to make students miss class, such as mental health, safety issues, and ensuring students feel a welcoming culture.

Commissioner Dang asked how the district will be moving forward with the potential school closures, to which Dr. Su said they're promoting schools to increase enrollment, and having deeper conversations about deeply under-enrolled schools. Dang also asked if layoffs will have a negative effect on enrollment, to which Dr. Su said that the first "teachers" to be laid off would be those who are currently not in the classroom.

Commissioner Kim asked how the school district is going to balance the budget while also addressing the needs of teachers, to which Dr. Su said they have made historic investments in recent years. Kim asked what the best way students can have their voices heard, to which Ray said to connect with their SFUSD Student Delegates to raise those concerns.

Dr. Su had to depart the meeting at 6:10pm, and Commissioner Ray was able to stay.

Commissioner Liao asked if the \$669.3 million was just state or state and local funds, to which Ray responded that she believes it's mostly state funds via student attendance.

Mayor Lurie and Dr. Su entered the meeting at 6:18pm to answer questions. Chair Fong asked if the school bus program could be merged with the Free Muni for All Youth program to save money, to which Dr. Su and Mayor Lurie said that the school bus program is specifically for young children.

Officer Yang asked how community partnerships will be affected with the cuts to the City and SFUSD budget, to which Dr. Su said that she and Mayor Lurie will make sure to use as many resources as they can to support students. Mayor Lurie discussed his budget outlook for this upcoming cycle.

Director Garcia asked how San Francisco being a City and a County affects the budget, to which Ray said it makes it more complicated because they are required to both be a local school district and a county-level board that provides educational guidance.

Officer Yang asked how SFUSD's Board of Education is currently supporting the Student Advisory Council, to which Ray said that another SFUSD employee is supporting SAC because the previous employee's position was eliminated due to budget cuts.

Vice Chair Listana asked what the projections are for combining classroom grades, to which Ray said that she hasn't seen any projections but that she believes there are examples that work well.

Chair Fong called for a 5-minute recess at 6:45pm, and called the meeting back to order at 6:53pm.

7. 2024-2025 Budget and Policy Priorities for FY 25-26 / 26-27 (First Reading)

Civic Engagement and Education Committee:

Chair Fong and Officer Liang read the Youth Civic Engagement BPP into the record, and there was no discussion or comments.

Commissioner Kim and Officer Yang read the Food Insecurity BPP into the record. Commissioner Fortgang said the research on the BPP is really great, and Commissioner Dang said that they should include what the Youth Commission has done in the past, in addition to what the BPP is advocating for.

Commissioner Marlow read the Mental Health BPP into the record. Commissioner Oram said it was very well researched. Officer Liang asked if there were any community organizations to include, to which Marlow said that she would look to put that information in there. Commissioner Fortgang added a potential change specific to the COVID-19 pandemic and the recommendations.

Commissioner Kim, Officer Yang, and Officer Liao read the Youth Development BPP into the record. Chair Fong recommended that any mention of "SF" be "the City" or "San Francisco", but the content is comprehensive and well done.

Commissioner Marlow read the Sexual Violence BPP into the record, and there was no discussion or comments.

Chair Fong called for a 3-minute recess at 7:52pm, and called the meeting back to order at 7:59pm.

Housing, Recreation, & Transit Committee:

Officer Liang, Commissioner Oram, Commissioner Krehlik, Commissioner Ansari, Commissioner Fortgang, Officer Liao, and Officer Valencia-Tow read the Transit BPP into the record. Chair Fong recommended that they could add language to SFUSD's mandated responsibilities to the school tripper section. Commissioner Dang recommended that there should be clarifying language around what the school tripper program is. Officer Liang asked if they reached out to SFMTA to ask about the feasibility considering the budget woes. Commissioner Marlow said the language looks really good. Chair Fong said this was exactly what he had envisioned in these BPPs, but recommended reformatting as well. Commissioner Fortgang said it might not be feasible, but that transitional-aged youth should be included in the language to be included in the Free Muni for All Youth program. Commissioner Dang asked if there were any instances of fare inspection officers being aggressive towards youth, to which Chair Fong said he hasn't but he knows that youth have been unfairly cited.

Commissioner Fortgang, Vice Chair Listana, and Officer Yang read the Climate BPP into the record. Officer Valencia-Tow recommended introducing some type of language around EV charging and how the production of batteries can pollute. Chair Fong also added that there should be additional issues included around the production of clean energy as well.

Officer Liao, Officer Valencia-Tow, Commissioner Ansari, and Chair Fong read the Housing BPP into the record. Commissioner Kim asked to reflect that it took 33 minutes to read this language. Commissioner Dang suggested putting pictures in the language since it's very text heavy. Officer Liang suggested a language change.

Officer Valencia-Tow took a point of personal privilege at 6:56pm, and returned at 6:58pm. Commissioner Kim took a point of personal privilege at 7:00pm, and returned at 7:04pm. Commissioner Marlow took a point of personal privilege at 8:45pm, and returned at 8:48pm.

Chair Fong, seconded by Commissioner Alameri, motioned to table the remainder of Item 7 through 13 to the next full Youth Commission meeting, and schedule a special full Youth Commission meeting on Monday, February 24th at 5pm. Officer Valencia-Tow explained the referred legislation, and Officer Liang explained that the resolution is a retroactive approval of this plan since the SFMTA Board of Directors has already approved the legislation. Valencia-Tow added that the Youth Commission should support this measure to ensure that public transit is financially supported, to which Chair Fong agreed to as well. Commissioner Kim asked if there's any concerns that they have, to which Liang said that he supports but there are some supervisors that

may not support because the resolution doesn't support a higher affordability rate. Specialist Zhan said that the reason for that is to give SFMTA the ability to negotiate with developers that may differentiate based on location and feasibility.

Chair Fong, seconded by Officer Valencia-Tow, motioned to positively recommend BOS File No. 250128. No discussion. No public comment. The motion carried by the following roll call vote:
