  - i. Legislative Affairs Officers

Officer Mordehai said the LAOs are planning on requesting to refer the Family Zoning Plan legislation to the Youth Commission. She said that speakers will be presenting that information to the YC in the near future as it's being discussed at the Board of Supervisors. Officer Mordehai gave the pros and cons of the legislation from the perspectives of the LAOs.

Officer Conboy gave an overview of the legislation, and stated it would be good because it would increase housing density, meet state housing goals to avoid penalties, make housing more affordable and equitable, give aid to small businesses, and replace any removed rent controlled units. The identified negatives include possible gentrification, lack of truly affordable housing, loss of neighborhood character, expensive construction costs could delay completed housing projects, loss of tenant protections, and political divisions due to the lack of trust in local government.

#### ii. Communication and Outreach Officers

Officer Jacques said they would be working towards intentional videos, visit youth-centered spaces that offer resources and services, engage in social media engagement, and authentically communicate with other youth.

Officer Azad said they would be interested in building community within the Youth Commission and plan events for commissioners to socialize.

#### iii. General Committee Updates

#### 1. Youth Commission Attendance

Director Esquivel Garcia gave an update on attendance tracking and said that the Executive Committee will be sure to connect with commissioners who may have trouble with attendance in the future.

Commissioner Conboy attended a District 7 Youth Council meeting to discuss the Family Zoning Plan and is supporting their advocacy work as they get organized.

Commissioner Shah met with former District 3 Youth Commissioner Winnie Liao and set up a structure of support as their liaison as they get started.

Commissioner Jacques gave more updates around plans for Youth Commission communications and outreach, their plans on recording videos to highlight youth, and a plan on

Commissioner Trujillo has been working hard over the past year to establish the District 9 Youth Council, in collaboration with the District 9 Office and YC Staff. He was also able to do the land acknowledgement at the Mayor's Latino Heritage Month Celebration a few weeks ago.

Commissioner Fortgang has been representing the SFYC on the California Association of Youth Commissions, and they've been working on different initiatives to highlight the needs of youth across the Bay Area. She is also organizing a virtual conference on Saturday, November 15th and said she would send more information about it soon.

Commissioner Lonné Amir helped write the resolution of commendations, she is working on a statement to prepare for the Commission Streamlining Task Force public comment, and she's excited to attend the Great Hauntway event later this month.

Commissioner Mordehai attended the Autumn Moon Festival in the Richmond District with Commissioner Moreno and Commissioner Yang. She is also working on putting together a District 1 Youth Council and will be seeking advice from other commissioners on how to get it started. She also spoke to Supervisor Chan to table at all other night markets across the City.

Commissioner Moreno joined Commissioner Mordehai and Commissioner Yang at the Autumn Moon Festival in the Richmond District, and she said it was a great time to connect with the community.

Officer Mordehai said that the LAOs would be requesting to refer a resolution urging SFPD to implement a comprehensive drug intervention plan around schools (BOS File #250991), BOS File #250968, and BOS File #250969

#### **14. Staff Report** (Informational)

Director Esquivel Garcia mentioned the SF Italian Heritage March on October 12th, and that Mayor Lurie invited the Youth Commission into their contingent. She also said that there is a Latino Heritage Month photo on October 15th, and she said that we will be tabling at the Great Hauntway with fun youth activities.

Specialist Zhan said she's currently planning everyone's first meetings with appointing officers sometime in the next two months, she is working to plan the photoshoot right before the next full YC meeting on October 20th, she is touching base with every BOS office to discuss the Family Zoning Plan, and she encouraged the Commissioners to talk to their peers about the zoning plan and housing overall.

Specialist Ochoa has been working on preparing the Youth Commission up for success with the Commission Streamlining Task Force, he will be sending an email with the link to give YC testimony for the CSTF and the link to a submission form for the YC's newsletters/social media, he will be sending HRT calendar invites for their meetings, he asked for folks to send any posts to the YC account to repost, and he said they can send any events to him and he will share with the rest of the Commission via Google Calendar.

The Board of Supervisors' Public Safety and Neighborhood Services Committee has received the following resolution request, introduced by Supervisor Stephen Sherrill on September 30, 2025. This item is being referred for comment and recommendation.

File No. 250991

[Prioritize Public Safety Response to Drug Activity Near Parks, Playgrounds, and Schools]

[Prioritize Public Safety Response to Drug Activity Near Parks, Playgrounds, and Schools] 1 2 3 Resolution urging the San Francisco Police Department (SFPD) to develop and 4 implement a comprehensive enforcement and intervention plan to address drug use or 5 suspected drug activity especially within 250 feet of parks, playgrounds, and schools, 6 including issuing citations, conducting assessments, and removing individuals for 7 processing or detoxification services. 8 9 WHEREAS, The City and County of San Francisco has a responsibility to protect the 10 health, safety, and welfare of all residents - especially children, families, and vulnerable populations who frequent parks, playgrounds, and schools; and 11 12 WHEREAS, The ongoing public health crisis involving the open use and trafficking of 13 illicit drugs in public spaces has raised significant concern among residents, educators, 14 parents, and community leaders; and 15 WHEREAS, San Francisco Police Department officers are dedicated to keeping San 16 Francisco residents and visitors safe; and 17 WHEREAS, San Francisco residents and visitors regularly express frustration and 18 confusion about which City service to contact in response to illegal or unsafe activity in their 19 neighborhoods, often receiving conflicting or inconsistent guidance about whether to call 3-1-20 1, San Francisco Police Department's non-emergency number, or 9-1-1, particularly in 21 situations involving public drug use, open-air dealing, or other ongoing street-level offenses; 22 and 23 WHEREAS, This lack of clarity undermines residents' confidence in the City's public 24 safety response, delays timely reporting, and places both community members and

1	emergency dispatchers in difficult positions when they are forced to guess which number to
2	call in situations that are urgent but not always life-threatening; and
3	WHEREAS, Parks, playgrounds, and schools are essential public spaces that provide
4	opportunities for recreation, education, and healthy development, and must be protected as
5	safe and drug-free zones; and
6	WHEREAS, Numerous incidents of drug use and drug-related activity have been
7	reported near playgrounds and schools, in some cases resulting in life-threatening situations
8	involving children; and
9	WHEREAS, Exposure to drug use or paraphernalia poses serious risks to the physical
10	and emotional health of children and undermines the safety and integrity of surrounding
11	neighborhoods; and
12	WHEREAS, Repeated drug activity in close proximity to these sensitive community
13	sites threatens public safety and the livability of neighborhoods throughout San Francisco;
14	and
15	WHEREAS, A coordinated public safety and public health response is necessary to
16	ensure that drug activity near parks, playgrounds, and schools is addressed promptly and
17	appropriately, balancing the need for enforcement with compassion and access to treatment;
18	and
19	WHEREAS, The City and County of San Francisco and the Board of Supervisors
20	support police officers enforcing the laws of the City and County of San Francisco and the
21	State of California regarding the sale and public consumption of illicit drugs; now, therefore,
22	be it
23	RESOLVED, That the Board of Supervisors of the City and County of San Francisco
24	urges the San Francisco Police Department to develop and implement a comprehensive plan

to respond to drug use, visible narcotics activity, or suspected drug trafficking occurring within

1	250 feet of any park, playground, or school, which shall include but not be limited to: Issuing
2	citations to individuals engaged in unlawful drug activity in these areas, conducting on-site
3	assessments to evaluate individuals' health and needs and removing individuals from the
4	vicinity for processing or referral to detoxification or treatment services, as appropriate; and,
5	be it
6	FURTHER RESOLVED, That the Board of Supervisors of the City and County of San
7	Francisco urges the SFPD to adopt technology tools to reduce the time and increase the
8	accuracy of citation writing and incident reporting in all forms; and, be it
9	FURTHER RESOLVED, That this comprehensive plan be in pursuit of an immediate
10	future where San Francisco's sidewalks and public spaces are free of the sale and use of illicit
11	drugs; and, be it
12	FURTHER RESOLVED, That this Resolution does not change existing laws or criminal
13	justice policies, but reaffirms the City's duty to ensure the safety of public spaces and to
14	provide coordinated interventions for individuals struggling with substance use; and, be it
15	FURTHER RESOLVED, That the Board of Supervisors requests the San Francisco
16	Police Department to report back within 60 days of the passage of this Resolution with a
17	detailed plan for implementation, including timelines, resource needs, coordination with health
18	and emergency departments, and any anticipated challenges; and, be it
19	FURTHER RESOLVED, that the Clerk of the Board of Supervisors shall transmit
20	copies of this resolution to the San Francisco Police Department, the Department of
21	Emergency Management, and the Department of Public Health for their review, collaboration,
22	and immediate consideration.

6	WHEREAS, According to the Department of Public Health's 2023 San Francisco
7	Biennial Food Security & Equity Report, two-thirds of San Francisco adults who are
8	making less than 200% of the Federal Poverty Line are food-insecure; and
9	WHEREAS, The recent closure of the grocery store at Bayview Plaza in District
10	10 has significantly reduced access to fresh and affordable food for local residents; and
11	WHEREAS, The lack of a nearby full-service grocery store threatens to create a
12	food desert, disproportionately affecting low-income families, seniors, and individuals
13	without reliable transportation; and
14	WHEREAS, Access to nutritious food is essential to community health, economic
15	stability, and overall quality of life, and is considered a fundamental issue of equity and
16	public well-being; and
17	WHEREAS, The Bayview community has long faced challenges in attracting and
18	retaining essential businesses that meet residents' daily needs, including grocery and
19	fresh food retailers; and
20	WHEREAS, According to the Department of Public Health's 2023 San Francisco
21	Biennial Food Security & Equity Report, the Bayview-Hunter's Point's age adjusted
22	hospitalization rates for diabetes, hypertension, and heart disease ranges between 1.6

1	to 3 times higher than the city's average age-adjusted hospitalization rate for these
2	conditions; and
3	WHEREAS, For Black/African American residents in San Francisco,
4	hospitalization rates were highest in 2021 for hypertension and heart disease than in
5	any year prior, with the rate of hospitalizations also increasing the most for Black/African
6	American residents compared to other groups; and
7	WHEREAS, The City and County of San Francisco has a responsibility to
8	promote food security and equitable access to healthy food options for all residents; and
9	WHEREAS, Partnering with community organizations, local developers, and
10	private grocery companies could help identify viable replacements and long-term
11	solutions to ensure continued access to groceries in District 10; now, therefore be it
12	RESOLVED, That the San Francisco Youth Commission urges the Mayor's
13	Office, the Office of Economic and Workforce Development, and the District 10
14	Supervisor's Office to prioritize efforts to secure a new grocery store operator in the
15	Bayview-Hunter's Point neighborhood; and be it
16	FURTHER RESOLVED, That the Board encourages collaboration with local
17	community groups, property owners, and private investors to develop sustainable
18	business incentives that ensure the long-term presence of a grocery store in the
19	Bayview-Hunter's Point neighborhood; and be it
20	FURTHER RESOLVED, That the staff of the San Francisco Youth Commission
21	shall transmit a copy of this resolution to the Mayor's Office and the District 10
22	Supervisor's Office for immediate consideration and action.
