  - i. Presenter: Legislative Affairs Officers

Items 7a and 7b were called together. Specialist Zhan read the most recent amendments to the Family Zoning Plan's legislation. Chair Listana encouraged commissioners to read through this bill since it's important and could likely

affect the next 10 years of San Francisco's housing crisis. Commissioner Shah said the HRT Committee focused on this legislation and talked about her biggest concerns regarding small businesses.

Officer Conboy and Officer Mordehai explained the legislation. Commissioner Oram said that people should be able to live their lives freely without worrying about federal interference, especially for immigrant communities. Vice Chair

Lonné Amir said it's very important to fund these initiatives. Chair Listana said uplifting immigrant communities is important and they need support.

Commissioner Yang said she attended the SFUSD Budget Town Hall, and helped lead the City Hall tour for the Climate Action Fellows earlier today.

- 12 2022, countless Ukrainian families have been displaced, with many young Ukrainians

- WHEREAS, United States Census Bureau data shows that about 14,000 Bay
- Area residents were born in Ukraine and about 26,000 claim Ukrainian ancestry. The
- 17 Bay Area has a larger number of residents with ties to Ukraine than any other city in
- California and in the United States, with 53 residents per 10,000 having a direct
- 19 ancestral tie to Ukraine, and San Francisco having 62 residents per 10,000 who claim
- 20 Ukrainian ancestry<sup>2</sup>; and

1	WHEREAS, The Richmond District of San Francisco, particularly the area
2	surrounding Geary Boulevard between 17th and 27th Avenues, hosts a significant
3	concentration of Ukrainian residents, businesses, and cultural institutions; and
4	WHEREAS, Local establishments such as Pushkin Restaurant, Leleka
5	Restaurant, Hromada SF, Ukrainian School of San Francisco, Holy Virgin Cathedral,
6	Immaculate Conception Ukrainian Catholic Church, Ukrainian Hall San Francisco, and
7	the Ukrainian American Coordinating Council serve as longstanding anchors of
8	Ukrainian heritage and community in San Francisco; and
9	WHEREAS, February 24th marks the anniversary of Russia's full-scale invasion
10	of Ukraine and serves as a solemn reminder of the ongoing struggle for peace,
11	democracy, and human rights. Commemorating this date provides an opportunity for the
12	San Francisco community to stand in solidarity with Ukraine, honor the lives lost, and
13	reaffirm the City's commitment to global justice and human dignity; and
14	WHEREAS, Youth in San Francisco have played an important role in preserving
15	Ukrainian culture through initiatives such as Slavic Voice 4 Ukraine, a youth-led media
16	and advocacy platform that promotes Ukrainian heritage, civic engagement, and
17	intercultural understanding through storytelling, oral history, and public programming.
18	Ukrainian youth at San Francisco State University have also been active in journalism,
19	advocacy, and cultural initiatives, helping raise awareness about Ukraine's history,
20	culture, and current challenges, and inspiring the next generation to engage with their
21	heritage <sup>34</sup> ; and

3	cultural and civic activities, and integrate into the community. Youth-led initiatives and
4	programs amplify the voices of young Ukrainians, promote intercultural understanding,
5	and ensure their experiences and contributions are recognized and celebrated <sup>5</sup> ; and
6	WHEREAS, Holodomor Memorial Day, observed annually on the fourth Saturday
7	of November, commemorates the millions of Ukrainians who perished in the man-made
8	famine of 1932–1933. At the height of the Holodomor in 1933, it is estimated that
9	Ukrainians died at a rate of 28,000 a day with nearly a third of the victims being children
10	younger than 10 years old; and this day provides an opportunity to educate the public
11	about this historical atrocity, honor the victims, and acknowledge its lasting impact on
12	Ukrainian culture, history, and diaspora communities <sup>67</sup> ; and
13	WHEREAS, Recognizing Holodomor Memorial Day in San Francisco would
14	honor the historical, cultural, and civic contributions of Ukrainian residents and affirm the
15	City's commitment to remembrance, education, and cultural understanding; now,
16	therefore, be it
17	RESOLVED, That the San Francisco Youth Commission urges the Mayor and the
18	Board of Supervisors of the City and County of San Francisco to designate the fourth
19	Saturday of November as Holodomor Memorial Day, to honor the lives lost and educate
20	the public about the historical significance of the Holodomor; and, be it

2	that the City and County of San Francisco commemorate February 24th as a Day of

1	[Upholding San Francisco's Commitment to its Newcomer Communities]
2	Resolution urging the Mayor and Board of Supervisors to protect and uphold San
3	Francisco's commitment to its newcomer communities.
4	WHEREAS, Following its January 20th, 2025, inauguration, the current Presidential
5	administration ("the administration") has forcibly escalated its anti-newcomer rhetoric; and
6	WHEREAS, the administration has adopted increasingly aggressive tactics to
7	persecute newcomers on legal status, such as arbitrary searches and apprehensions,
8	including of U.S. citizens and permanent residents; and
9	WHEREAS, The administration is pursuing legally unprecedented policy, prompting
10	many legal experts to deem its actions illegal and unconstitutional; and
11	WHEREAS, San Francisco is among cities such as Chicago, Los Angeles, and New
12	York targeted by the administration for historically protecting newcomers through Immigration
13	and Customs Enforcement (ICE), Department of Homeland Security (DHS), and Homeland
14	Security Investigations (HSI) agent raids in areas with significant newcomer presence; and
15	WHEREAS, As an instance of legally unprecedented and targeted raids, and in what
16	was called a violation of "due process rights," by attorney Milli Atkinson of the San Francisco
17	Bar Association, four asylum-seekers attending pending asylum hearings were arrested at
18	San Francisco's 100 Montgomery Street building, according to reports from the San Francisco
19	Standard, the Associated Press, SFGATE, among others; and
20	WHEREAS, Concerns around the treatment and the honoring of the rights of
21	newcomer detainees have prompted surveying visits to ICE facilities in San Francisco by
22	Supervisors

1	Fielder, Chen, and Dorsey, with Supervisor Mahmood prohibited from entering facilities on an
2	attempted visit; and
3	WHEREAS, Undocumented youth and children are especially vulnerable to anti-
4	newcomer rhetoric and policy, including reported apprehensions of minors and their families
5	during ICE raids; and
6	WHEREAS, Pursuant to San Francisco Administrative Code § 12H.1-12H.5 and §§
7	12I.1-12I.5, the City and County of San Francisco has declared itself a place of refuge for all
8	residents, including newcomers; and
9	WHEREAS, San Francisco Administrative Code § 12H.2. maintains that "No
10	department, agency, commission, officer, or employee of the City and County of San
11	Francisco shall use any City funds or resources to assist in the enforcement of Federal
12	immigration law or to gather or disseminate information regarding release status of individuals
13	or any other such personal information unless such assistance is required by Federal or
14	State statute, regulation, or court decision"; now, therefore, be it
15	RESOLVED, That the San Francisco Youth Commission urges the Mayor's Office and
16	the Board of Supervisors to do more to protect and defend San Francisco's status as a safe
17	haven for newcomers; and, be it
18	FURTHER RESOLVED, That the Mayor and Board further employ means of combating
19	the administration's threats to San Francisco's safe haven status, including via legislation and
20	the direction of city departments; and, be it

1	FURTHER RESOLVED, That the Mayor and Board hold city departments and actors
2	violating San Francisco's Administrative Code in aiding the unwarranted apprehension of
3	newcomers in San Francisco accountable; and, be it
4	FURTHER RESOLVED, That the Mayor and Board and hold law enforcement and
5	those sharing San Francisco police data, such as license plate data from Automated License
6	Plate Readers (ALPR) operated by the San Francisco Police Department, accountable
7	through the enactment of penalties for aiding in the apprehension of newcomers; and, be it
8	FURTHER RESOLVED, That the Mayor and Board explore the creation or expansion
9	of legal literacy efforts among San Francisco's newcomer communities, especially in
10	languages not covered by San Francisco's Language Access Ordinance, including Indigenous
11	languages; and, be it
12	FURTHER RESOLVED, That the Mayor and Board explore the creation or expansion
13	of legal literacy curricula or easily accessible resources in San Francisco Unified School
14	District (SFUSD) schools aimed at students who are undocumented or with undocumented
15	family members; and, be it
16	FURTHER RESOLVED, That the Mayor and Board expand funding to legal aid
17	nonprofits and organizations servicing newcomers through changes to fiscal policy or city
18	budget where feasible; and, be it
19	FURTHER RESOLVED, That the Mayor more overtly address and denounce the
20	administration's unprecedented and aggressive apprehension of newcomers in San
21	Francisco, especially of children and minors; and, be it



### San Francisco's Fiscal Year 2025-26 Budget: \$15.9 billion



### **Board of Supervisors Authority & Powers**

San Francisco Charter

Article 2: Board of Supervisors



- The Board of Supervisors cannot interfere with administrative actions, but has the full power of hearing and inquiry
- The Board can adopt legislation regarding administrative matters other than specific contract and personnel decisions

#### SEC. 2.114. NON-INTERFERENCE IN ADMINISTRATION.


Except for the purpose of inquiry, the Board of Supervisors shall deal with the administrative service for which the City Administrator is responsible solely through such officer, and for administrative or other functions for which elective officials or boards or commissions are responsible solely through the elective official, the board or commission or the chief executive officer of such board or commission concerned, or their designees.

Neither the Board of Supervisors, its committees, nor any of its members, shall have any power or authority, nor shall they dictate, suggest or interfere with respect to any appointment, promotion, compensation, disciplinary action, contract or requisition for purchase or other administrative actions or recommendations of the City Administrator or of department heads under the City Administrator or under the respective boards and commissions. The Board of Supervisors shall deal with administrative matters only in the manner provided by this Charter, and any dictation, suggestion or interference herein prohibited on the part of any Supervisor shall constitute official misconduct; provided, however, that nothing herein contained shall restrict the power of hearing and inquiry as provided in this Charter.

Notwithstanding any other provisions of this section, it shall not constitute prohibited interference for a member of the Board of Supervisors to testify regarding administrative matters other than specific contract and personnel decisions at a public meeting of a City board, commission, task force or other appointive body, or for the Board of Supervisors to adopt legislation regarding administrative matters other than specific contract and personnel decisions.

Violation of this section shall constitute official misconduct.
