## **6. Presentations**

### **a. Mayor's Office of Victim and Witness Rights and SHARP**

i. Presenter: Lila Carrillo, SHARP Director

SHARP Director Carrillo gave a comprehensive presentation on their office's mission, vision, and objectives of their work.

Officer Jacques asked what's a moment they realized they needed to change their approach, to which Carrillo said they learned that they need to be listening more than telling, as well as that one-size doesn't fit all and their office needs to be prepared to address all of the nuances that come along with the complications of crime victims.

Commissioner Elias asked how youth cases are treated differently, to which Carrillo said they take a comprehensive approach with all of their clients, but they also help support parents who are helping their child through this process.

Officer Mordehai asked how they do outreach and how the Youth Commission can help extend knowledge of their office's services, to which Carrillo said the YC can help by uplifting the various spaces that their offices create to provide a platform to address sexual harassment and assault in all spaces.

Commissioner Mon asked if their current convenings have been effective in doing the work they seek to do, to which Carrillo said the results have been mixed since the structures are different in each space they have those meetings.

Officer Conboy asked what's something they wish youth understood about common misunderstandings about the process, to which Carrillo said understanding the youth resources that are currently offered to those who need it.

Commissioner Yang asked her to expand what types of curriculum MOVR can inform SFUSD's curriculum on, to which Carrillo said they don't inform them on these issues yet, but they're currently exploring how their office and SFUSD can work more closely together to protect and inform youth of their rights to understand how to get support if they need it.

Chair Listana asked how they hope to work with SFUSD youth, despite SFUSD's curriculum isn't under their prerogative but at the same time the SFUSD's Title IX Committee remains inactive in addressing issues, to which Carrillo said having more of a partnership with the school district to have much more of an intimate ability to address problems when they arise.

Commissioner Shah took a point of personal privilege at 5:44pm, and returned at 5:55pm.

Officer Conboy asked if those who qualify get to choose what facility their child will attend to receive childcare. Officer Mordehai asked to what extent Prop C has improved the lives of families to have their childcare needs met.

b. **BOS File No. 251197** - Hearing - Conditions for Women in Custody at Local Jails - Sheriff's Department Oversight, Policies and Procedures

Officer Conboy explained the legislation.

Officer Jacques asked if the women who were affected by the sheriffs' misconduct will be supported to make sure that they're okay. Chair Listana asked what types of oversight were they that could've prevented this from happening. Vice Chair Lonné Amir asked if they knew if the police personnel were disciplined due to their actions. Officer Mordehai asked why there was such a huge delay in this story coming out since it was claimed to happen in May, and we only know about it 8 months later. Commissioner Elias asked how we eliminate bias when it comes to who's coming into these jails. Commissioner Shah asked if this event will trigger further investigations into what types of situations have happened in the past, including in other facilities like Juvenile Hall. Commissioner Oram asked why strip searches are allowed at all when the article says that the jail has the technology to scan people without having to strip search. Officer Jacques asked why there were male deputies present when it was women who were being searched, and not women deputies. Commissioner Marlow asked what the consequences would be for the deputies who broke the law. Commissioner Trujillo asked if the Department of Police Accountability were the ones investigating. Chair Listana asked why the Sheriffs Oversight Accountability Board hasn't been funded to be

fully staffed and supported. Commissioner Mon asked if the resolution and calls for action have been introduced yet. Commissioner Moreno asked what other policies were ignored and what consequences there would be if they were ignored.

No major updates, but Officer Jacques is interested in putting forward an event to feed the homeless since it hasn't been done yet. She's also reaching out to reschedule interviews with Commissioners.

Vice Chair Lonné Amir said attendance is still looking good and no one is in danger yet, and that everyone's participation is looking great. She also mentioned that the Mid-Year Winter Retreat will be taking place on MLK Weekend on January 17th and 18th, and she let them know to tell staff if they will not be able to attend since they count for attendance as full YC meetings. They also took count of who can attend the FYC meetings on January 5th and 12th, which looked like 1/12 would be better attended. Happy holidays!

- b. Transformative Justice Committee

Commissioner Trujillo said they would be focusing on BPPs soon.

- c. Housing, Recreation, and Transit Committee

Commissioner Oram said they discussed some resolutions and talked about BPPs from last year.

- d. Civic Engagement and Education Committee

Commissioner Marlow said they discussed BPPs.

#### **10. Roll Call, Introductions, and Announcements** (Informational)

Commissioner Conboy said she met with the District 7 Youth Council to discuss their current projects and a town hall, and she talked to Supervisor Melgar and her own priorities.

Commissioner Shah said she met with Supervisor Sauter, she's considering writing a resolution about MUNI funding for school trippers and youth employment in the parks and rec department, and she met with a Napa County Supervisor.

Commissioner Jacques said she wanted to resurface her idea about the public safety kiosk idea to see who may be interested in working on that idea with her, to which Commissioner Marlow, Shah, Elias, Listana, Lonné Amir, and others raised their hands. Specialist Zhan will help schedule a meeting with folks from Minneapolis on this project.

Commissioner Trujillo said he was able to meet with Supervisor Fielder last week about both of their priorities, discussed her opposition to the Family Zoning Plan, and other issues in District 9.

Commissioner Fortgang said she attended the CAYC conference last month, she presented on the state legislative processes and how youth can be stronger advocates, and she met with the Climate Literacy Advocates.

Commissioner Lonné Amir said she wrote the two motions that they passed at today's meeting, she was able to talk to someone from the Library Commission, she was able to talk with Mayor Lurie briefly, and she's currently scheduling a meeting with her CBO.

Commissioner Mon said she attended the Lowell High School Opportunity Fair with YC Staff, and she discussed the Family Zoning Plan with parents and students.

Commissioner Mordehai said she is still receiving applications for the District 1 Youth Council and she's working on a more concrete plan for the Council, and

she wanted to see if anyone wants to work with her on a resolution on protecting free speech and against book bans.

Commissioner Moreno said she attended the Student Success Fund Council meeting and it was very welcoming, and she's working on the D1YC Youth Empowerment Fund project.

b. Other Legislative Introductions and Announcements

Officer Jacques was being open and honest and spoke about her truth. She talked about certain neighborhoods needing more of a voice in the room, and that she feels that she's seen in a different light because of her background. She feels that there is a sense of overcompetition and it makes it difficult to be her authentic self. She joined the YC to fight for her community, and wants to collectively fight together for their communities.

Chair Listana thanked Officer Jacques for her honesty and for calling everyone into the Youth Commission's mission.

**11. Staff Report (Informational)**

Director Esquivel Garcia said they need to finish their HR trainings by December 31st as is required by the City, she said that staff will not be communicating as much over the next two weeks since it's the holidays, and said to relax before the intensity of the BPP process starting in January.

Specialist Zhan gave her report.

Specialist Ochoa said the United Educators of SF conducted a strike authorization vote with 99.3% of their members voting YES. This means that if they move forward with another vote and it passes, they will officially be on strike. They are doing this because they've been in nine months of negotiations with SFUSD's administration to fight for improved conditions for special education, better healthcare benefits, increased wages for our teachers, and codifying sanctuary school status into the district's governing documents. If you'd like to know more, please let me know and I can forward you the email with details. He'll also be working with Officer Jacques to schedule a community service activity sometime soon to feed our unhoused neighbors or do another service-providing opportunity. He thanked her for bringing this idea up.

There being no further business on the agenda, the full Youth Commission adjourned at 7:16pm.






1 [Recognition of February as Teen Dating Violence Awareness and Prevention Month]

2 **Resolution recognizing February as Teen Dating Violence Awareness and  
3 Prevention Month.**

4 WHEREAS, 1 in 10 high schoolers have experienced physical violence from a  
5 dating partner during the past year; and

6 WHEREAS, 1 in 5 victims say they experienced digital abuse or harassment at  
7 school during school hours; most takes place away from school grounds; and

8 WHEREAS, Young people are impacted by abusive relationships as they are  
9 threatened with or subjected to physical violence, sexual violence, psychological  
10 aggression, or stalking from a current or former intimate partner; and

11 WHEREAS, Dating violence can also occur digitally through social media and  
12 other electronic communication in the form of cyberstalking, non-consensual distribution  
13 of intimate images, and other technology-facilitated harms; and

14 WHEREAS, Young people experiencing violence are more likely to be vulnerable  
15 to long-term behavioral and health consequences, including mental trauma and drug  
16 abuse; and

17 WHEREAS, Victims of digital abuse and harassment are two times as likely to be  
18 psychologically abused, two times as likely to be physically abused, and five times as  
19 likely to be sexually coerced; and

20 WHEREAS, Trauma from adolescent domestic violence increases the risk of  
21 violence in adulthood and future relationships; and

1        WHEREAS, It is crucial to educate young people about the signs of domestic  
2 violence, to set them up for success by allowing them to recognize for themselves what  
3 healthy, nonviolent relationships look like; and

4        WHEREAS, San Francisco Youth Commission shall partner with Asian Women's  
5 Shelter and Black Women Revolt Against Domestic Violence to bring awareness to the  
6 Teen Dating Violence Awareness Month (TDVAM) 2026 Event and raise awareness  
7 about the impact of teen dating violence on San Francisco Youth; and therefore be it

8        RESOLVED, That the San Francisco Youth Commission recognizes the month of  
9 February as Teen Dating Violence Awareness and Prevention Month to affirm the right  
10 of all young people to experience healthy relationships free from dating abuse in  
11 adolescence and beyond; and therefore be it

12        FURTHER RESOLVED, That the San Francisco Youth Commission introduce  
13 and urge the Mayor, Board of Supervisors, and other elected officials representing San  
14 Francisco to recognize the month of February as Teen Dating Violence Awareness and  
15 Prevention Month to encourage and facilitate the education of teen dating violence for  
16 all young people in the City and County of San Francisco; and therefore be it

17        FURTHER RESOLVED, That the San Francisco Youth Commission attends  
18 Black Women Revolt and Asian Women Shelter's Teen Dating Violence Awareness  
19 Event, Real Love Respects, on February 7th, 2026, at the Visitacion Valley Public  
20 Library Branch; and therefore be it

21        FURTHER RESOLVED, That the San Francisco Youth Commission encourages  
22 the Mayor, Board of Supervisors, and other elected officials representing San Francisco  
23 to wear orange on February 10, 2025; and therefore be it

- 1        FURTHER RESOLVED, That San Francisco Youth Commission staff are
- 2        directed to transmit copies of this resolution to the Office of the Mayor, Board of
- 3        Supervisors, and other elected officials representing San Francisco.

1 [Addressing Human Trafficking in San Francisco]  
2 **Resolution urging the Board of Supervisors and the Mayor to put more funding**  
3 **into resources combating human trafficking and recognizing the month of**  
4 **January as Human Trafficking Awareness and Prevention Month.**

5 WHEREAS, Human trafficking has remained a pressing issue across the world,  
6 with 38% of trafficking victims being children since 2022, according to the United  
7 Nations Office on Drugs and Crime; and

8 WHEREAS, The United Nations Office on Drugs and Crime released its 2025  
9 global report on trafficking and found 38% of those impacted were trafficked for sexual  
10 reasons, with 64% being women and 28% being girls. However, 42% of people  
11 impacted were trafficked for labor, which consists of 47% of them being men and 20%  
12 being boys.

13 WHEREAS, There were 165 cases of human trafficking localized in San  
14 Francisco in 2021, down from 673 in 2017. Though there is the possibility of an  
15 undercounting of human trafficking cases. In 2023, there were 20 San Francisco Police  
16 Department (SFPD) incidents reported, though if the number of undercounts was 6%,  
17 this could mean a total of 333 cases, and with an undercount of 18%, a total of 111  
18 cases; and

19 WHEREAS, San Francisco receives over \$9 million allocated to support  
20 programs for human trafficking survivors, and to emphasize efforts to combat child sex  
21 trafficking and deliver comprehensive services; and

1            WHEREAS, The City of San Francisco and the Department on the Status of  
2    Women released a report on human trafficking data from 2022-2023 in San Francisco  
3    on December 31st, 2024, interviewing 18 agencies; and

4            WHEREAS, The report noted approximately 38% of victims were under the age  
5    of 25, with 10% being minors and 28% being Transitional Aged Youth (TAY); and

6            WHEREAS, The report also reported that about 88% of all reported cases were  
7    people of color. African Americans comprised the largest block of trafficked individuals,  
8    making up 57% of all cases. Hispanic/Latinx individuals were 18% of all cases, White  
9    individuals were 12% of all cases, and Asian/Pacific Islanders were 8% of all cases; and

10           WHEREAS, Many agencies, such as Black Women's Revolt, Asian Women's  
11   Center, San Francisco Collaborative Against Human Trafficking, San Francisco  
12   Collaborative Against Human Trafficking Student Alliance, SF Safe House, and  
13   Women's Housing Coalition, have emphasized that financial support is a high need to  
14   aid services for survivors, including legal support, housing, medical attention, and much  
15   more; and

16           WHEREAS, On October 30, 2024, the Budget and Legislative Analyst (BLA) for  
17   the Board of Supervisors published a policy analysis report, presenting policy  
18   recommendations for anti-human trafficking initiatives in the City and County of San  
19   Francisco. The recommendations include the SFPD increasing staff for human  
20   trafficking cases, the Office of Labor Standards Enforcement developing labor trafficking  
21   protocols, and encouraging the District Attorney's office and SFPD to strengthen their  
22   collaboration through task forces, case reviews, and joint training sessions; and

1           WHEREAS, The Youth Commission has provided support for Freedom  
2       Forward's HYPE Center (Helping Young People Elevate) to continue to receive funding  
3       to combat human trafficking in MOTION NO. 2324-AL-25 after receiving no funding  
4       through the Department of Children, Youth, and Families RFP; and

5           WHEREAS, The Youth Commission has worked closely with Black Women  
6       Revolt and Asian Women's Shelter to put a spotlight on the effects of human trafficking  
7       amongst young people in San Francisco; and

8           RESOLVED, The Youth Commission urges the Mayor and the Board of  
9       Supervisors to urge the San Francisco Police Department to train more officers to  
10      specialize in human trafficking; and therefore be it

11          FURTHER RESOLVED, That the San Francisco Youth Commission recognizes  
12      the month of January as Human Trafficking Awareness and Prevention Month; and  
13      therefore be it

14          FURTHER RESOLVED, The Youth Commission urges the Mayor and the Board  
15      of Supervisors to fund efforts to prevent and combat human trafficking during the  
16      SuperBowl and FIFA World Cup in the Bay Area and allocate more funding dedicated to  
17      preventing human trafficking and helping trafficking victims; and therefore be it

18          FURTHER RESOLVED, That the San Francisco Youth Commission urges the  
19      Mayor, Board of Supervisors, and other elected officials representing San Francisco to  
20      approve or support BOS FILE NO. 260032, which recognizes the month of January  
21      2026 as "National Human Trafficking Prevention Month" to encourage and champion  
22      prevention programs for all young people in the City and County of San Francisco who  
23      may be at risk of human trafficking; and therefore be it

- 1        FURTHER RESOLVED, That San Francisco Youth Commission staff are
- 2        directed to transmit copies of this resolution to the Office of the Mayor, Board of
- 3        Supervisors, and other elected officials representing San Francisco.
