### C. Discussion on March Solidarity Rally

Commissioners Juarez, Matz, and Lind decided that a solidarity rally of targeted groups: Muslim and Arab youth, immigrant youth, and LGBTQ (especially trans) youth would be a priority for March. Supervisor Kim's office is the one that put this request forward, based off of feedback from some other community organizations, and Commissioners will a) bring this forward to the full YC meeting on Monday to see if anyone else is interested in planning b) tentatively request that it be held on March 20<sup>th</sup> before a full YC meeting c) ask that Emma and Cris postpone their second reading of the anti-Trump resolution so that they can do that the same day as the rally to invite youth to witness it's passing.

### D. Debrief last full YC meeting

EC is very concerned about attendance. Commissioner Matz will send out an email regarding attendance this week. Agenda item is already focused on attendance from the last meeting and Commissioner Matz will be more forceful in adhering to the by laws and charter and what they state about attendance. They will also offer up themselves as folks to connect with if anyone is struggling with attendance.

### E. Discussion on the Youth Commission Convention

Marin County Youth Commission is hosting a gathering of YCs from across the Bay on April 22<sup>nd</sup>. EC will be in charge of gathering up names and those who are committed to attend this. There is the conflict with the Bay Area Youth agencies who are organizing an overnight learning retreat in how to resist the Trump Administration.

Commissioner Lind will meet with Leah and has offered to help with any tabling outreach needs. Staff updated the Committee that Commissioner Vargas wishes to step down from his role as Outreach and Communication officer which takes him off the EC, which then means full YC needs to do a bylaws change.
