- There are 10-12 departments funding YWD and TAY programs (i.e. HSA, PUC, OEWD, DCYF, RPD, JPD, APD, Airport)
- There's not a common way of assessing or helping young people navigate the options for YWD programs. The youth council (WISF) used to be convened by OEWD but no longer is. That was a useful space for these discussions, but did not necessarily rise to the level of having common intakes, etc.
- o Assessment of sector needs is based on which industries step up to the plate
- DCYF is announcing next five years of grants soon. Should represent investments in young adults as well.
- Invite OEWD out to hear about tech training ideas
- Talk to peer resources about youth worker (CCSF) and educator pathway ideas.
