a. Discussion of Leadership Structure

Joshua Rudy Ochoa, YC staff, explained the options of what the leadership structure of the committee could look like for the committee. Commissioners came to a consensus for a Chair / Vice Chair structure for the HLU Committee.

Commissioners discussed their priorities to focus on within the HLU Committee:

- i. Housing & Homelessness
 - 1. Build Affordable Housing (below market rate, for youth & families)
 - 2. For youth leaving home for the first time, do they have the resources to get housing
 - a. Transactional costs + additional costs as barriers
 - 3. More family-size housing built
 - Increase Oversight of SROs, HSH, and Homeless Shelters

 Monitor the potential Prop C if it passes
- ii. Recreation & Parks
 - 1. Investing in Park Improvement & Accessibility
 - 2. Slow Streets Program (keep monitoring the hearing that's in December)
 - 3. Expand Youth-Centered Spaces
 - a. Anish: what kind of spaces are the youth-centered spaces?
 - b. Making these spaces more accessible to teens and TAY
 - c. Safe recreational spaces for youths.
 - 4. If Prop J passes, look into how to make the Great Highway and JFK more accessible
 - 5. Increasing access to the eastside parks iii. Transportation
 - 1. Overcrowding on Student-Heavy Muni Routes (28, 29, 18, M, etc.)
 - a. Chair Miller requested a presentation and submitted it to staff
 - b. Need to collect more data from youths on which bus lines are affected by overcrowding
 - 2. Restoring Critical Muni Routes (10, 47, 76x)
 - a. Why isn't the L switching back to a train?
 - i. Chair Miller responds
 - 3. Expanding and Integrating Bike Network
 - 4. Expanding Bike Storage & Safety
 - 5. Discounted / Free BART for Youth
