The San Francisco Youth Commission's Housing & Land Use Committee met remotely in regular session through videoconferencing, and provided public comment through teleconferencing, on Tuesday, October 24, 2022, with Chair Hayden Miller presiding.

1. Call to Order and Roll Call for Attendance

Chair Miller called the meeting to order at 5:32pm.

Commissioners discussed their favorite spots in San Francisco, and what they enjoy doing throughout the City. They also discussed what neighborhood they'd love to live in if affordability wasn't an issue.

b. Debrief of HLU Retreat

Commissioners discussed their takeaways from the retreat. Commissioner Nguyen said that they narrowed down their focus onto specific priorities to start on: bike storage, how the City went about demolishing the Octavia freeway, TAY navigation in the Sunset, etc. Chair Miller noted that not all of the committee members were present, but that it's not to worry since they'll continue those discussions.

Chair Miller created a spreadsheet to break down and track the HLU's legislative priorities, in order to ensure they're on track to deliver on those issues. Chair Miller also noted that if there's any additional items to put on the tracker, to do so now so committee members can delegate and participate. Commissioner Nguyen pointed out it would be best to focus on projects one at a time, so they're not overwhelmed and doing them all at the same time. Commissioner Nguyen is interested in focusing on BART youth fares and freeway removal, and Commissioner Adair is interested in overcrowding on student-heavy MUNI routes and BART youth fares. Chair Miller and commissioners agreed that they'd like to have presentations, do research, write resolutions, and possibly call hearings. Staff will support moving forward on reaching out to the right folks. Chair Miller also stated that he and Vice Chair Barker Plummer are working on a resolution related to the recent BOS hearing on SFMTA bus stops. Chair Miller highlighted that these priorities are on the spreadsheet that he created to focus on their legislative priorities.

d. HLU-related Updates

Commissioner Nguyen said that this was discussed during the previous agenda item, so there's nothing new to add at this time.

8. SFMTA Bus Stop Hearing (discussion & possible action)

Chair Miller said that he was present at this hearing, which gave a lot of information and insight to what was taking place in this discussion at the Board of Supervisors' Land Use and Transportation committee meeting on Monday, October 17th. As stated before, Chair Miller and other commissioners are going to be working on a resolution to address the issues highlighted in this hearing.

9. Ocean Ave Mobility Action Plan Task Force Town Hall & Survey (discussion item)

Commissioner Nguyen is informing the committee that this task force has created a new survey, and she's asking commissioners how to best spread awareness. She'll also be reaching out to the Communication and Outreach Officers to help put the survey on social media.
