Officer Lonné Amir thanked the Commissioners who have filled out the Google Form, and she's still waiting for four more to complete the form. She added that she'll be meeting with the person about the mental health and tech conference on Friday, since it was moved from today. She said that the Comms Officers might also be taking additional photos and videos at the full Youth Commission meeting next week.

- d. Updates on Recent Youth-Related Board of Supervisors / Mayor Legislation
 - i. Presenters: Allister Adair & Jason Fong, Legislative Affairs Officers

Officer Adair said that there wasn't a lot of big legislation that took place at this past week's BOS meeting. He added that there's one piece of legislation that they may be interested in looking at regarding residential beds.

Officer Fong said that they're reaching out to Commissioners about legislative priorities to help focus on how to best implement their priorities into action.

e. Bylaws

Chair Barker Plummer went over the list of bylaw amendments that are being proposed for the Commission to adopt from last year.

Officer Adair asked if refusing to accept a letter of resignation is the only thing that needs a supermajority vote, to which staff said yes. He added that the way the random drawing went fine this year, but that a discussion beforehand might be good to have.

Specialist Zhan explained the portion amending the legislation language section, and Director Garcia explained that we need to determine a process for accepting the participation of youth-at-large, especially if the bylaw amendment passes.



Chair Barker Plummer, seconded by Officer Adair, motioned to move the bylaw amendments forward to the full Youth Commission with a positive recommendation. No discussion. No public comment. The motion carried by the following voice vote:

f. Budget and Policy Priorities Timeline

Chair Barker Plummer and Specialist Zhan went through the proposed timeline for the upcoming BPP processes. He said BPPs will be starting to formulate during committee meetings in December, and will start coming together at the beginning of the next calendar year in January.

Specialist Zhan went through the timeline and explained staff presentations that will take place throughout the next few weeks and months. She also discussed the implementation of town halls into the timeline before the final approval of the BPPs to ensure that community voices can be heard and implemented into the Youth Commission's priorities.

Officer Adair said he believes that they should try and keep all Commissioners involved in the BPP process, even after the BPPs are approved. Chair Barker Plummer added that the Executive Committee should be there to make sure that everyone feels supported throughout the process.

g. Youth Commission Opportunities

Director Garcia said that the Police Commission and other community members are interested in collaborating with the Youth Commission. Staff said they didn't remember what exactly information to propose for this item, but they'll bring it back at the following Executive Committee meeting.
