- a. Resolution Valencia Street Protected Bike Lanes
 - [Resolution urging SFMTA to install curbside protected bike lanes or pedestrianized Valencia St., between 15th and Cesar Chavez St. to reduce traffic fatalities and increase public safety]
 - ii. Sponsors: Commissioners Ansari, Fong, and Wong

Commissioners read the resolution language into the record. Commissioner Wong said they should clarify what NACTO stands for. Chair Ansari mentioned that Vice Chair Fong wants the first line or title of the resolution to be stronger. Commissioner Adair said that they should add a clause at the end that highlights who they're sending the resolution to, including Luke Bornheimer's effort, Better Valencia. Specialist Ochoa recommended that they include community-based organizations like WalkSF, SF Bike Coalition, and the Vision Zero Task Force.

Commissioner Adair proposed retitling the resolution to be "Resolution urging SFMTA to replace center bike lanes on Valencia St between 15th St and Cesar Chavez St. with curbside protected bike lanes to reduce traffic fatalities and increase public safety. Commissioners also removed language regarding the pedestrianization of Valencia Street to stay focused on the original intent of the resolution.

Commissioner Wong, seconded by Commissioner Lampkins, motioned to approve the "Resolution urging SFMTA to replace center bike lanes on Valencia St between 15th St and Cesar Chavez St. with curbside protected bike lanes to reduce traffic fatalities and increase public safety", with language amendments. No public comment. The motion carried by the following voice vote:

- i. [Resolution urging the Mayor and Board of Supervisors to urge the SFMTA Board of Directors to take immediate action on a No Turn On Red (NTOR) citywide policy in light of recent traffic incidents and ongoing safety concerns]
- ii. Sponsors: Commissioners Fong and Wong

Commissioners read the resolution language into the record. Vice Chair Fong said to remove the clause discussing other cities where it's been implemented. Commissioner Wong said they should correct some capitalization and formatting errors, said that they should add a clause at the end that highlights who they're sending the resolution to, including: Mayor's Office, SF Board of Supervisors, SFMTA Board of Directors, No Turn on Red San Francisco, WalkSF, SF Bike Coalition, and the Vision Zero Task Force.

Vice Chair Fong, seconded by Commissioner Lampkins, motioned to approve the "Resolution urging the Mayor and Board of Supervisors to urge the SFMTA Board of Directors to take immediate action on a No Turn On Red (NTOR) citywide policy in light of recent traffic incidents and ongoing safety concerns", with language and grammatical amendments.
