The San Francisco Youth Commission's Executive Committee met in-person with remote access for public comment, on March 27, 2024, with Vice Chair Listana presiding.

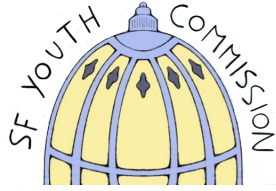
1. Call to Order and Roll Call for Attendance

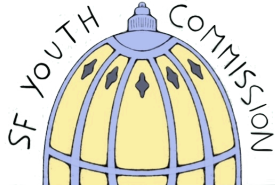
4. Approval of Minutes (Action Item)

b. Discussion and Debrief of March 18, 2024 full Youth Commission Meeting

Vice Chair Listana said that the presentations were all great and there was great participation from commissioners. Chair Barker Plummer said that he really liked the inclusion of citywide governing bodies that several Youth Commissioners sit on, and looks forward to that being included in a revolving update during roll call and introductions.

6. Committee Business (discussion and action item)

a. Community Builder

Vice Chair Listana was happy to have a community builder question, and asked what everyone's dream job was when they were growing up and what their dream job is now.

b. Budget and Policy Priorities Presentation Discussion

Vice Chair Listana said she thinks the presentation went very well and was glad that the Supervisors asked insightful questions. Chair Barker Plummer said that he thought the presentation was very strong, and that the Commission should continue to build stronger relationships with the appointing officers. Director Garcia said that the Youth Commission's efforts are finally being taken seriously and are starting to look at how they'll implement the YC's goals into the budget.

c. Review Commission Attendance

Director Garcia went over the attendance and highlighted that Officer Wu has zero excused absences remaining for Executive Committee, Commissioner Cisneros only has one remaining excused absence for HRT Committee, and Commissioner Faagau-Noa has zero excused absences remaining for the full



Commission meetings. Most of the commissioners have very little or no recorded absences, which is great in comparison to previous terms.

- d. Updates on Commission Outreach and Communications
 - i. Presenters: Téa Lonné Amir & Kelly Wu, Communication and Outreach Officers

Officer Lonné Amir said that the YC takeovers are now taking place on Instagram and she is going to be touching base with the commissioners who have yet to sign up for a slot for Cherry Blossom Festival tabling opportunity. Officer Wu also discussed the upcoming information sessions for recruitment.

- e. Updates on Recent Youth-Related Board of Supervisors / Mayor Legislation
 - i. Presenters: Allister Adair & Jason Fong, Legislative Affairs Officers

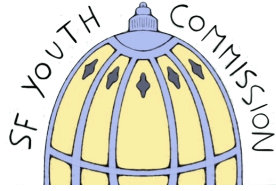
Officer Adair said he will be making sure to support every commissioner in their meetings with appointing officers, and remind them to take photos to share the advocacy that the YC is doing. Officer Fong discussed the legislation that will be referred to and put on the agenda for April 1st, which includes BOS File 240144 [Hearing - Departmental Compliance for Language Access], BOS File 240211 [MOU between SFPUC and SFUSD - Installation, Operation, and Maintenance of Green Infrastructure], BOS File 240239 [Resolution urging HSH to Develop a Comprehensive Plan that Prioritizes Families with Children to Receive Shelter], and BOS File 240244 [Hearing - Emergency Response Times and Quality of Engagement with School Sites].

- f. Future Advocacy Planning

Chair Barker Plummer introduced the conversation of what the future of budget advocacy will look like, now that the presentation to the BOS is done. He thinks that all commissioners should do public comment and check-in with the offices of their appointing officer to follow-up on the BPPs. He added that the YC should do public comment on the final day to ensure the BPPs are passed. Chair Barker Plummer added that he will send an email soon regarding the Vote16 rally at City Hall on April 24th at 4pm.
