The San Francisco Youth Commission met in-person with remote viewing on December 11, 2024, with Vice Chair Listana presiding.

### 1. Call to Order and Roll Call for Attendance

b. Discussion and Debrief of November 18, 2024 and December 2, 2024 full Youth Commission Meeting

Director Garcia recapped the presentations, discussions, and actions that took place at both meetings. Vice Chair Listana said she was glad to see all of the engagement and vibes with the budget presentation. Chair Fong said that Tracy did a great job discussing the budget, and thought both meetings went well. Commissioners also mentioned that they're glad that the presenters for the Yosemite Slough plan are starting to do more youth outreach.

c. Review Youth Community Budget Forum

Chair Fong said that the turnout was much stronger than past years, and that there was a lot of group representation from Districts 10 and 11. Officer Liang said that they can address this by going around to do additional outreach to specific communities. Officer Yang said she hopes commissioners can reach out to various community-based organizations to ensure additional voters are heard that way.

- d. Updates on Commission Outreach and Communications
  - i. Presenters: Winnie Liao & Emily Yang, Comms & Outreach Officers

Officer Liao said he's working on social media posts for a youth budget forum recap, commissioner introductions, and asked for any additional posts. Director

Garcia said that she would post a few things onto social media, and would put it on the comms tracker.

e. Updates on Recent Youth-Related Board of Supervisors / Mayor Legislation
i. Presenters: Lucas Liang & Jin Valencia-Tow, Legislative Affairs Officers

Officer Valencia-Tow said he's hoping to reach out to schools more, and that he's glad that the rapid rehousing legislation passed at the BOS meeting on Tuesday. Director Garcia said that she can ask our office intern to do more research on some policies, and Officer Valencia-Tow said that he would like to see legislative digests that make it easier to understand what policies are being proposed at the local and state level. Officer Liang had no updates.

f. Approval of Full Youth Commission December 16, 2024 Agenda

Officer Valencia-Tow said a BOS legislative aide may be in discussions of helping unionize City Hall interns, to which the staff and officers said they are supportive of continuing this discussion offline and see how to be supportive of the youth interns.
