Officer Fong said he was disappointed that commissioners were put into this situation since they shouldn't have had to choose between supporting critical community organization funding and direct food security government services.

BOS File No. 240676 - Charter Amendment - Student Success Fund - Charter Amendment (First Draft) to amend the Charter of the City and County of San Francisco to provide that money set aside for the San Francisco Unified School District in the Student Success Fund cannot replace, supplant, count as, or substitute for other City funding for the School District or children and youth required under the Children and Youth Fund, the Public Education Enrichment



Fund, or other provisions in the Charter; at an election to be held on November 5, 2024.

i. Presenter: YC Staff

Officer Fong introduced the legislation referred to, and staff clarified questions about why this is also going to the ballot for this upcoming November.
