7. Committee Business (action item)

a. Community Outreach Update

Commissioner Yang met with many CBOs for the budget and policy priorities report. Commissioner Fong has many meetings scheduled. Chair Marlow met with SF Parks Alliance and Drug Free Sidewalks.

b. Meeting with SFUSD Infrastructure Manager Update and Recap

The meeting was positive. However, there was a feeling of uncertainty. SFUSD hasn't gotten back to Commissioner Yang and Vice Chair Kim, so the Commissioners will follow up with her. The biggest problem is staffing, but there's some budgeted already.

Ranking is based on prioritization, such as hazardous places. The process is very long. Prop A is only for modernization and capital improvements. Only one handyman and a bunch of contractors, and SFUSD is struggling to find contractors AND hiring permanent handyman positions.

SFUSD thinks the Master Plan is realistic. Commissioner Yang spoke to Student Nutrition Services, and they think it will be finished in 5 years, but the infrastructure manager thinks it will be finished in 8 years.

Cadi expressed surprise at the lack of student and teacher input. She hopes the Youth Commission can help with the outreach, but she wants to present to the full Commission.

Commissioner Fong expressed that the Youth Commission shouldn't be the sole group responsible for talking in schools, and it should be more on the Student Advisory Council. Perhaps the Youth Commission can advocate for the SAC to help with the school outreach.

Commissioner Yang has been trying to get responses from the SAC survey.

Chair Marlow wants the committee to have the second reading by the end of May at the Full Commission with or without the data from SFUSD.

c. Resolution Updates

Chair Marlow, Commissioner Yang, and Commissioner Oram are working on a resolution regarding reducing plastic waste. Staff encourages the Committee to include goals from the SF Climate Action Plan.

The Committee talks about the next resolution that the CEEC should work on. Commissioners Yang and Fong discussed a resolution regarding the Student Advisory Council.

d. CEEC-related Updates and Current Events

AB1121 - Literacy in special education. Chair Marlow is going to file a motion. Will include it in the next committee meeting.

Staff will start scheduling 1:1s with the Committee members.
