#### b. Training: Resolution Writing and Research

Staff provides training on resolution writing and research. Commissioners discuss a resolution idea that they have.

Chair Conboy aims to address food security in public schools and ensure students have access to healthy food options. Additionally, she wants to improve SFUSD curriculum and see where areas of improvements could be.

Commissioner Yang hopes to continue the resolution she was writing last term on AI and its impact on education. She also aims to address food security and the access to school meals. In the wake of the ongoing impact on newcomers, she is advocating for newcomer youth support services.

Commissioner Moreno aims to address school safety, especially during emergencies, she hopes to have better communications between administration and schools.

Commissioner Marlow hopes to have a more interactive educational curriculum, and level the disparity between public and private schools.

Commissioner Jacques wants to write a resolution about the public kiosk that she saw in Minneapolis, with the goal to increase public safety and access to public services, she hopes to bring something similar to San Francisco.

#### c. Goal Setting and Legislative Priorities

Staff asks CEEC if they're open to partnering with SFUSD on a survey, and someone from the District can come to the next CEEC meeting.

Commissioner Jacques presents her survey draft. The Committee asks questions and discusses the survey draft.
