Vice Chair Listana asked how the meeting went since she was absent, to which Officers discussed the agenda items and SFMTA presentation. Chair Fong said he wished commissioners asked more questions, but was glad many HRT members asked questions about Free Muni for All Youth.

Officer Lucas entered the meeting at 5:14pm.

  - a. Community Builder / Icebreaker

Vice Chair Listana asked how everyone's winter break was and what the most exciting thing they did was, to which everyone answered.

b. Review Commission Attendance

Specialist Zhan said the only commissioner that staff are concerned about is with Commissioner Majdoub, since she currently have two excused and unexcused absences in the Civic Engagement and Education Committee, meaning she's one unexcused absence away from being removed from committee. c. Review Youth Community Budget Forum #2

The second Youth Community Budget Forum is planned to be on Wednesday, February 5th, 4pm to 6pm, and it will likely take place at the Main Branch of the San Francisco Public Library. The Comms Officers said they will be working on the flyer for this event in the next week.

#### d. Retreat Overview

Specialist Zhan said the schedule has changed based on the event taking place on the morning of January 18th. She added that Saturday will be from 1pm to 3pm, and Sunday will be 10am to 3pm, to adjust for Saturday's schedule change.

Officer Yang said they're going to start working on application recruitment with 4 community events in the coming Spring, and Specialist Ochoa discussed the details about the new community builder event ideas.

  - i. Presenters: Lucas Liang & Jin Valencia-Tow, Legislative Affairs Officers

Officer Liang said that the Mayor's Office has called for a Fentanyl State of Emergency, and they're looking more into that legislation. Liang added that they're finalizing details and encouraging others to schedule smaller budget forums. There is one coming up with LYRIC scheduled for January 28th. Chair Fong said that if there's capacity and an urge to do so, they could host a virtual budget community forum to get more input in the final weeks before they pass.

Officer Valencia-Tow said that he and Officer Liang are trying to encourage and incentivize more commissioners to write more resolutions.
