The San Francisco Youth Commission's Executive Committee met in-person with remote viewing on March 12, 2025, with Vice Chair Listana presiding.

## 1. Call to Order and Roll Call for Attendance

Vice Chair Listana called the meeting to order at 5:10pm.

b. Discussion and Debrief of March 3, 2025 full Youth Commission meeting

Chair Fong said the meeting began strongly but felt that people's behaviors got a bit out of control at the end, and hopes everyone can maintain decorum at all of our meetings. Chair Fong added that he thinks there could've been more input from different commissioners. Vice Chair Listana said they could've had more questions to ask the presenters. Chair Fong added he has seen some of the commissioners doing homework during meetings, and said that that should not be the priority, especially during presentations.

5. Public Comment on matters not on Today's Agenda (2 minutes per comment)

- **6. Committee Business** (all items to follow are discussion and possible action)
  - a. Community Builder / Icebreaker

Vice Chair Listana moved past this item due to time constraints.

b. Review Commission Attendance

Specialist Zhan reported back about the attendance for several commissioners whose attendance should be addressed, and that Commissioner Paea's letter of resignation will be on the upcoming full Youth Commission meeting since she has now exceeded the number of FYC unexcused absences.

- c. Updates on Commission Outreach and Communications
  - i. Presenters: Winnie Liao & Emily Yang, Comms & Outreach Officers

Officer Yang asked commissioners to sign up for the Instagram Takeovers if they haven't already. Specialist Ochoa asked Chair Fong and Officer Liang to fill it out by Friday if they can.

- d. Updates on Recent Youth-Related Board of Supervisors / Mayor Legislation
  - i. Presenters: Lucas Liang & Jin Valencia-Tow, Legislative Affairs Officers

Officer Liang said that there wasn't any legislation that was youth-related, and that all of the legislation that the Youth Commission has positively recommended has passed at the SF Board of Supervisors. Chair Fong asked if the LAOs could put together a fiscal outlook. Officers discussed working on more resolutions now that BPPs have been passed.

e. Budget and Policy Priorities - Prioritization Conversation

Vice Chair Listana said that the Transformative Justice Committee chose the Workforce Development BPP (#1) and the Justice Systems BPP (#2) as their priorities. Officer Yang said that the Civic Engagement and Education Committee chose the Food Insecurity BPP (#1) and the Youth Development BPP (#2) as their priorities. Specialist Ochoa said that the Housing, Recreation, and Transit Committee chose the Housing BPP (#1) and the Climate BPP (#2) as their priorities.

Officer Valencia-Tow and Chair Fong both said they want the Transit BPP to be mentioned as well, since it is a huge priority. Specialist Ochoa said that climate, transit, and street safety were all vying to be HRT's #2 priority, and that they're all very interconnected and they can mention that at the presentation.

f. BOS Budget and Appropriations Presentations Prep

Chair Fong went through the run-of-show for next week's presentation, and the Executive Officers did a practice run of their BOS BPP Presentation. YC Staff and Officer Yang asked practice clarifying questions and gave feedback for the Budget and Appropriations Committee YC BPP presentation next Wednesday.
