Housing, Recreation, & Transit Committee:

Commissioner Ansari and Commissioner Krehlik read the Street Safety BPP into the record. Commissioner Ansari said they feel that bike lanes and hate crimes could be separate BPPs. Chair Fong recommended they should add language around reinstating Vision Zero as a goal, and said that more context could help integrate the hate crimes language into the street safety BPP. Vice Chair Listana said that they can do more to connect the fare inspectors language into the goals of the HRT Committee. There is consensus amongst commissioners to separate the two issues into two separate BPPs, and the authors will work on language before it's finally passed at the next full Youth Commission meeting. Specialist

Zhan mentioned they should consider including the Hate Crimes BPP language into the Justice System BPP.

Commissioner Ansari read the Recreational Spaces BPP into the record, and there was no discussion or comments.

Transformative Justice Committee:

Commissioner Alameri read the Workforce Development BPP into the record. Commissioner Marlow recommended incorporating examples from various other countries on how to support trade schools. Chair Fong recommended that there be alternatives to ensure that trade schools are treated fairly compared to college in the language. Commissioner Fortgang mentioned that there is overlap with the other BPPs, since there is a shared data point and it would be good to make sure they're connected to one another.

Commissioner Lonné Amir read the Violence Prevention BPP into the record, and there was no discussion or comments.

Vice Chair Listana read the Family Protections BPP into the record. Chair Fong recommended making formatting adjustments for quotes. Commissioner Ansari recommended adding images to break up the long text in the language.

Commissioner Dang read the Justice System BPP into the record. Commissioner Krehlik said that this priority does feel different from the Hate Crimes BPP, so it might not be a good language combination into this one.

Chair Fong called for a 5-minute recess at 6:19pm, and called the meeting back to order at 6:31pm.

2024 - 2025 Budget and Policies Priorities for FY 25-26 / 26-27 (Second Reading) (Discussion and Possible Action)

a. Youth Civic Engagement

Chair Fong said no changes were made to this BPP.

b. Food Insecurity

Commissioner Kim stated the changes based on feedback from last week's full Commission meeting.

c. Mental Health

Commissioner Marlow added additional language to improve the COVID-19 section, and included more community organizations throughout the BPP. Chair Fong said it would be good to reduce how much language is in the BPP.

d. Youth Development

Officer Yang said there were no major changes, but she added more photos to the document.

e. Sexual Violence

Chair Fong said no changes were made to this BPP.

f. Transit

Commissioner Ansari added more language about the Clipper program, and other minor changes.

g. Climate

Commissioner Oram added recommendation language about school buses that was recommended at the last full Commission meeting. Commissioner Fortgang said minor changes were made to their BPPs.

h. Housing

Commissioner Ansari added images to the Affordable Housing BPP, and read into the record a new paragraph regarding middle-income housing.

Chair Fong asked the full Commission if it's the desire of the commissioners to pass the BPPs that are ready today or to wait until the next full Commission meeting to pass all of the BPPs. Commissioners gave feedback preferring to pass them at the next full Youth Commission meeting.

Specialist Ochoa went over the 2025/2026 recruitment and application timeline for the upcoming Youth Commission cohort. Officer Yang said they're working on the 2025/26 YC Application and "Meet Your Commissioner" community builder flyers. She added that they're going to post a Teen Dating Violence post soon.

Vice Chair Listana said there are no updates from the last meeting. She reminded everyone to read through the BPPs and finalize any last changes by this Thursday. Executive Committee members will be going through and making final recommendations over the next few days as they review all of the language.

Commissioner Kim said they read over all of their BPP language.

c. Housing, Recreation, & Transit Committee

Commissioner Fortgang said they read through their BPPs and gave comments since they last met.

d. Transformative Justice Committee

Commissioner Lonné Amir said they didn't have a quorum to call the meeting to order, but they had a working meeting to work on the BPP language.

10. Roll Call and Introductions (discussion item)

Roll call for introduction of resolutions, requests for hearings, letters of inquiry, and Commissioners' reports on their Commission-related activities.

 a. Presenters: Commissioner Valencia-Tow, Commissioner Liao, Commissioner Fong, Commissioner Dang, Commissioner Fortgang, Commissioner Lonné Amir, Commissioner Alameri, Commissioner Kim, and Commissioner Krehlik.

Commissioner Valencia-Tow is absent.

Commissioner Liao is absent.

Commissioner Fong said he's been working with the District 7 Youth Council on their final project in collaboration with SFMTA, as well as working with Vice Chair Listana with an award nomination process with APA.

Commissioner Dang said she's been working mostly on BPPs, as well as working on a school project about co-sponsoring anti-human trafficking legislation. She will be meeting with Assemblymember Stefani to discuss further action, and said that Supervisor Chen met with her class and said that she hopes to see the creation of a D11 Youth Council.

Commissioner Fortgang said she was able to present to the CalAcademy with Vice Chair Listana and Officer Yang, she attended the District 8 Budget Forum with LYRIC, and is working with teachers to help inform her BPP language. She added that she's focused on planning to attend the California Association of Youth Commissions with other commissioners.

Commissioner Lonné Amir said they're working on the human trafficking resolution with Commissioner Dang and a foster youth resolution. She's also starting to have conversations with peers about applying to the YC next year.

Commissioner Alameri said she attended the Tenderloin Action Group which focuses on how to invest and support different community projects. She said she was able to meet recently with her appointing officer, Supervisor Mahmood, and what changes she'd like to see him support in the Tenderloin.

Commissioner Kim said she worked on the BPP language and helped publish an article about the CIS Leadership program, and she's writing another article in April. She'll be focusing on the SFUSD district budget to better understand what budget crisis they're facing.

Commissioner Krehlik said she attended the Mayor's inauguration, she helped encourage civic engagement with other middle school students, she attended the Lunar New Year celebration in City Hall, she participated in the Lunar New Year Celebration Parade in San Francisco, and worked on the BPP language.

b. Other Legislative Introductions

No other legislative introductions.

11. Staff Report (discussion item)

Director Esquivel Garcia reminded everyone to check their City Portal for any new city trainings to complete, she reminded commissioners and staff to continue filling out the logs to track their responsibilities and time spent on commission work, and she will send

out information regarding events we've been invited to. Specialist Zhan asked for any suggestions on designs for the BPP report, she said that if anyone wants their inaugural pictures to let her know, and that the next meeting will have two presentations while also passing BPPs. Specialist Ochoa announced that there'll be a "Meet Your Commissioner" community builder on March 1st (11am-1pm) at My Cup of Tea.

12. Announcements (this includes Community Events)

Officer Liang said that he checked his calendar and will no longer be able to serve in the Youth Seat on the Juvenile Justice Coordinating Council due to scheduling, in which Chair Fong then went back into Item 8b for reconsideration. Commissioner Alameri said there will be an Arbor Day opportunity to play games and learn more about volunteer opportunities.

13. Adjournment

There being no further business on the agenda, the full Youth Commission adjourned at 7:30pm.
