# 5. Public Comment on matters not on Today's Agenda (2 minutes per comment)

No public comment.

#### 6. Presentations

- a. WalkSF
  - i. Presenter: Malena Mackey Cabada, WalkSF Campaign Associate

Malena Mackey Cabada gave their presentation to the Commission on the most recent data on deadly and serious injuries due to car-related crashes.

Officer Valencia-Tow asked if there's any future plans to advocate for No Turn on Red (NTOR) infrastructure, to which Cabada said they have advocated for NTOR and that she knows the SFMTA is currently considering how to expand the NTOR in various neighborhoods across the City.

Commissioner Ansari asked if there are specific streets they've advocated for lower speed limits and have seen positive results, to which Cabada said that they have advocated for lower speeds and speed safety cameras on Fulton St and are focused on expanding that vision.

Officer Liao asked how speed safety cameras have reduced speeds and if they have data, to which Cabada said while the program has just started a month ago and may not have all of the data currently, these cameras have been proven to work in other cities like in Canada. She hopes that the data is successful so they can go to Sacramento to ask for more speed safety cameras.

Officer Liang asked what WalkSF's message is to frustrated residents since residents in the Sunset District feel alienated, to which Cabada said they want people to have safer and accessible choices of travel and that includes drivers, pedestrians, and everyone else.

Commissioner Oram asked if they've been working with SFPD on addressing the enforcement of speeding, to which Cabada said yes, but they've mainly been working with the Board of Supervisors on addressing the behavior of speeding across the City.

Officer Yang asked how they integrate community input into their policy priorities via surveying, to which Cabada said she hasn't received surveying results but that residents do seem frustrated that change seems to be slower than they would expect. She also mentioned that there are voices that are missing from the conversation that they continue to outreach to.

Commissioner Kim asked if WalkSF knows exactly why the traffic fatalities were so high in 2024, to which Cabada said she isn't sure of the exact reason, but that shifts in behavior, more cars on the road, the lack of infrastructure, and others of why there were so many fatalities and injuries.

Chair Fong asked what the Youth Commission can do to support the mission of WalkSF since we advise the Mayor and BOS, to which Cabada said that having youth voices at the table are critical to pushing our City's leaders to push for a Vision Zero 2.0 since there has not been movement on that effort yet.

## b. Expanding Housing Choice

Presenter: David Garcia, Planner & Reanna Tong, Senior Planner

Reanna Tong and David Garcia presented on the expansion of housing choices with their updated 2025 upzoning plans by the SF Planning Department.

Commissioner Krehlik asked what density decontrol means, to which Tong said that term means it loosens the regulations of how dense a lot has to be while also following safety and building code regulations.

Commissioner Dang asked how low-income households can continue to afford to live throughout the City and not just concentrated in specific neighborhoods, to which Garcia said they are pushing to include more affordable housing into their new 2025 plan in all housing opportunity zones. Tong added that the Planning Department is working to have more inclusionary housing

Officer Valencia-Tow asked what they're doing to expand tenant protections, to which Garcia said that tenants are able to move back into a building at the same rate as their previous housing if their building is redeveloped. Valencia-Tow followed up and said that he believes that it is often the case that it's unrealistic for tenants to move back into their old housing since these projects often take years to do so, to which Garcia said they're being as conscious as they can to ensure that tenants are protected.

Officer Liang asked if there would still be setback requirements in their plans, to which Garcia said yes. Officer Liang asked if streets like Taraval St or Noriega St would be adjusted for their setbacks, to which Tong said that design standards would still remain in place. Officer Liang asked if these projects as zoned can still use the state's density bonus on specific projects, to which Tong said they're trying their best to use their zoning legislation to account for that potential bonus.

Officer Liao asked how they can support small businesses through potential redevelopment, to which Tong said developers have to pay any small business at least 18 months of payment for relocation pay, as well as supporting micro-retail policies to ensure that diverse sizes of businesses are able to afford to rent in new developed buildings.

Chair Fong asked what happens next after the City passes all of these zoning policies and what options they have to encourage developers to build if they refuse to build, to which Garcia said they acknowledge that they don't hold all of the levels to encourage development like interest rates or project costs, but that they are doing their best to do what they have to power to legislate in the housing element proposal.

Officer Liao took a point of personal privilege at 6:06pm, and returned at 6:10pm.
