6. Presentation (Discussion and Possible Action)

- a. San Francisco Transportation Plan
 - i. Presenter: County Transportation Authority

Suany Chough, the SFCTA Assistant Planning Director, gave their presentation on the San Francisco Transportation Plan 2050+.

Chair Fong asked for clarification of the differences between SFCTA and the other various city and regional transportation agencies, to which Chough clarified.

Officer Valencia-Tow asked how they equitably measured the shifts in low-income travel methods, to which Chough said they look at target metrics, job trends, and equity evaluation model.

Chair Fong said the Youth Commission can distribute the feedback survey amongst Commissioners and our networks.

7. 2025 - 2026 Bylaws Amendments (First Reading)

a. Presenter: Youth Commission Staff

Specialist Ochoa presented the proposed staff and Exec-approved recommendations to the San Francisco Youth Commission's Bylaws, in order to be further in compliance with the City Charter.

Vice Chair Listana said that the mention of "Our Children Our Families council" is still present in several sections of the current Bylaws, to which Specialist Ochoa said Staff will remove those before presenting them at the next full Youth Commission meeting.

Chair Fong asked for clarification of Section 5A, to which Specialist Ochoa clarified.

Chair Fong and Vice Chair Listana read the statement into the record.

Commissioner Fortgang suggested removing the fifth paragraph (page 2) since it's too far outside the jurisdiction of the Commission. Officer Valencia-Tow and Commissioner Dang said that they prefer to keep the language in the motion. Commissioner Lonné Amir said it could be useful to mention the 'No King's Movement' in the statement, since it gives the motion more of a concrete example.

iii. General Committee Updates

Vice Chair Listana said the only update was the updates to the proposed Youth Commission's bylaws. Chair Fong mentioned that if anyone wants to introduce Resolutions of Commendations at the next FYC meeting, to connect with staff or the Chair/Vice Chair.

b. Civic Engagement and Education Committee

Commissioner Kim said they had a long conversation with the youth from the Student Advisory Council, and they discussed resolution updates.

c. Housing, Recreation, & Transit Committee

Commissioner Fortgang said they had their last HRT Committee meeting last week, and they passed a resolution in support of a citywide climate action day.

d. Transformative Justice Committee

Commissioner Lonné Amir said they did not meet last week.

11. Staff Report (discussion item)

Director Esquivel Garcia said there will be a Know Your Rights Workshop on Sunday at 10:30am at MLVS, and said she will email the rest of her updates. Specialist Zhan said she is finalizing scheduling budget meetings, and encouraged all to walk into their appointing offices as much as they can. Specialist Ochoa announced that there will be a YC Public Comment Workshop in City Hall's Room 278 on Wednesday, June 18th, from

5:30pm-6:30pm, and to show up if they're not able to attend Public Comment Day on June 23rd. He also mentioned that staff are finishing finalist interviews for the 2025/26 Youth Commission next week.

12. Announcements (this includes Community Events)

Officer Valencia-Tow announced that he created a monitor spreadsheet for all of the legislations that this term has taken action on, and that staff will share it with everyone. Chair Fong congratulated the Class of 2025 for graduating.
