Resolution In Support of Expanding Electric Vehicle (EV) Charger Concentration  
Throughout San Francisco.

Officer Yang noted that Commissioner Fortgang is a sponsor. Commissioners read the resolution into the record. Officer Liang pointed out a small correction in the language regarding the type of electric vehicle (EV) chargers. Commissioner Dang asked about the breakdown of EVs by district since some may not have enough demand to build more EV chargers, to which Officer Yang said that they have the data by zip code and that the southern neighborhoods of the City needed a greater amount of public EV chargers.

Chair Fong called for a 10-minute recess at 5:46pm, and called the meeting back to order at 6:12pm. Officer Liao and Officer Yang discussed the changes to the resolution language into the record. Commissioner Fortgang added context.

- d. **RESOLUTION NO. 2425-RC-01: [CEQA Reform Commendation]** - Resolution commending Governor Gavin Newsom, Senator Scott Weiner, Assemblymember Buffy Wicks, and the California Legislature for passing CEQA reforms that streamline construction of urban homes, child care centers, and other essential facilities.

- i. Sponsor: Liang

Officer Liang read the resolution into the record. Commissioner Fortgang said she supports CEQA reforms in concept, but two of the pieces of legislation that were passed with these reforms were strongly opposed by many environmental organizations across California, so she has strong concerns about the legislation. Commissioner Fortgang brought up examples of concerns specifically regarding superconductor pollution.

Commissioner Dang asked for clarification regarding CEQA and what types of projects it exempts from the CEQA process. Vice Chair Listana recommended that they move forward without including any references to SB 131, since that's where the contention is.

Officer Yang, seconded by Vice Chair Listana, motioned to approve Resolution No. 2425-RC-01, with the amendments to remove all references to SB 131 and allow for grammatical edits. No discussion. No public comment. The motion carried by the following roll call vote:

Liang said the Prop C funding passed on first reading by a 8-3 vote, with Fielder, Walton, and Chen in opposition.
