  - a. Icebreaker

Commissioner Valencia-Tow asked what they would say or do instead of saying "present", to which commissioners and staff answered.

- b. Resolution No. 2425-AL-06: [24-Divisadero MUNI Extension] Resolution urging the Mayor and the Board of Supervisors to extend the 24-Divisadero bus from its ending place at Jackson and Weber St. to the Presidio Transit Center
  - i. Presenter: Commissioner Oram

Commissioner Oram gave an update on the feedback she's received on this resolution, and asked for additional information to update it. Commissioners and staff gave feedback on how to make the resolution have stronger language and next steps.

- c. Resolution No. 2425-AL-XX: Resolution urging the Mayor and Board of Supervisors to implement lower speed limits to Alemany Boulevard and the 19th Avenue/Juniperro Serra intersection to reduce the risk of pedestrian-vehicle collisions
  - i. Presenter: Chair Ansari

Commissioners read through the resolution on their own. Commissioner Oram said WalkSF should be added since they're a vocal advocate for street safety. Commissioner Valencia-Tow said that it would be good to add additional language to the last two whereas clauses.

h. WalkSF Activity for April 28th

Specialist Ochoa discussed the details of the WalkSF activity on street safety on April 28th. He said to meet at the front steps of City Hall where we will start the one-hour activity.
