The San Francisco Youth Commission's Civic Engagement and Education Committee met in-person with remote viewing, on January 26, 2026, with Chair Yang presiding.

7. Committee Business (Discussion/Action)

- a. Resolution No. 2526-AL-11 - Resolution to Support MyPath Bill of RYTS
 - i. Sponsor Yang

Commissioner Conboy agrees with all of MyPath's asks and recommendations. Her main question is how the Youth Commission should support them. Chair Yang and Vice Chair Marlow met with them, and the main way to support them is by community outreach. Commissioner Moreno agreed with all of their recommendations, especially around guaranteed income, so what are their plans? Committee staff suggests looking into the existing San Francisco guaranteed income programs. Vice Chair Marlow asked a question to MyPath about financial literacy. Commission Elias supports it, but how can we ensure that the people are being helped by the programs, and how can this be reached by the youth and practiced the skills? The Committee suggests putting the resources in places where young people can congregate, more publicity, having accessible language by defining some of the terminology with MyPath, putting it in classrooms, and partnering with other CBOs.

The Committee had a discussion about the financial literacy curriculum in schools. The basic SFUSD curriculum is integrated into the Freshman course, College and Career. The Committee suggests making it interactive and having more hands-on experience. The question is whether young people actually use it. In private schools, it's outside of class workshops through parents or outside community partners, but there are specific classes that are focused on this. There is something to teach parents about how to teach their kids. There are also financial aid workshops. Generally, they are working with the community, public, and/or private entities.

Vice Chair Marlow leaves at 5:29 PM and returns at 5:34 PM.

Chair Yang discusses the planning and delegation for the resolution. Commissioner Elias will work on the efficiency and public outreach parts, Commissioner Conboy will work on the accessible language piece, and Commissioner Moreno will work on the community organization partnership and outreach pieces. The first draft should be done by February 6th for the

February 9th CEEC agenda. The Committee will present to the Full Youth Commission on March 2nd.

b. 2025/2026 Budget and Policy Priorities (BPP) Discussion and Planning

Commissioner Moreno is researching the Gender Based Violence Prevention BPP and started contributing to the other BPPs. Vice Chair Marlow wrote the recommendations and the background section for her BPPs. Commissioner Elias is working on a BPP around mental health and college prep access. Commissioner Conboy is working on reports on school curriculum, recommendations for Prop C, climate education, and Bayview Hunter's Point. Chair Yang is working on the collaborative reports, and then work on CEEC focused ones. She is also meeting with community organizations.

c. Youth Commission Survey Planning and Updates

Staff provides an update. Vice Chair Marlow inquires about the Youth Vote organization.

d. Community Outreach Reports

Vice Chair Marlow met with two students who want to start a D2YC, who are concerned about empty storefronts. Chair Yang sent many emails to CBOs for her BPPs. Commissioner Elias also emailed CBOs for outreach, worked with safety with the Transformative Justice Committee, and wants to connect with someone from Burton High School regarding what happened last month with the student shooting.

e. Committee Community Civic Engagement Day Planning

Chair Yang suggests partnering with different CBOs to do voter preregistration and registration drives. Vice Chair Marlow plans to attend the Teen Dating Violence Awareness Month event and suggests CEEC could attend together. Commissioner Conboy suggests tabling at night markets. Chair Yang asks the Committee for their thoughts on partnering with the Student Advisory Council on an SFUSD townhall.

Commissioner Elias left the room at 5:49 pm and returned at 5:50 pm.
