Acting Director Zhan said attendance is mostly good, but mentioned that some commissioners have almost met their maximum amount of allowable excused absences, so that's something to be aware of.

- i. Presenters: Communication and Outreach Officers

Officer Azad welcomed Officer Shah for being the newly elected Comms Officer and for joining the Executive Committee. Officer Shah said she's figuring things out as they go.

- d. Youth-Related Board of Supervisors / Mayor Legislation Updates
 - i. Presenters: Legislative Affairs Officers

Officer Conboy said there's nothing on the legislation introduction list that they saw that needs to be referred, except for Supervisor Melgar's introduction of a resolution to support equity for women. She said it expects it to be heard at the full Board of Supervisors meeting in early March. Officer Mordehai said they're working on an LAO project to give tours to youth groups around City Hall, and that they're planning for at least one of them to be at all of the youth budget forums.

- e. 2025/2026 Budget and Policy Priorities First Draft Review

Chair Listana said that the deadline has been extended for everyone to finish giving their input and suggestions by Thursday, February 19th. She also asked for feedback on the process thus far within each committee, and Officers gave their input. HRT has been doing well, CEEC has no complaints at the moment, and TJ has had some trouble on the non-collaborative BPPs.
