She is also working on a youth employment BPP with Commissioner Yang, and they aim to set up a meeting with DCYF or JCYC. Commissioner Lonné Amir is working on a reducing weapons access BPP report also with CEEC. She is also aiming to meet with OCEIA to discuss resources when it comes to immigration and language access. Commissioners Lonné Amir and Listana will working an overarching Youth Commission BPP relating to Commission staffing and charter reform. The Committee will also work on a BPP report on economic empowerment containing workplace rights and financial literacy. Vice Chair Trujillo is working with Commissioner Yang on AI governance and relations. He is also exploring public safety measures around the BART Plazas. Commissioner Mordehai asks to schedule meetings with Open Door Legal and the District Attorney's human trafficking unit.

Chair Mon is working on a letter of support for the SDDTAC recommendations. Commissioner Lonné Amir spoke at the Reproductive Rights rally and will report back to the Commission.
