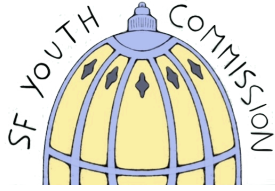
**6. Committee Business** (all items to follow are discussion & possible action)

a. Icebreaker

Chair Ansari asked "if you could have any job, what job would you have?" The commissioners and staff answered the icebreaker question.

b. Youth Primary Housing Assessment Criteria

Specialist Ochoa said that YC staff met with the Executive Director of the HYPE Center and discussed a potential conversation to have to bring people together to draft a better youth primary housing assessment. Commissioner Adair said they should have more information about the scoring system, and the entire process for homeless youth.



Commissioners and staff said that they can come to the next HRT Committee meeting with more information, and Specialist Ochoa said he can invite the ED from HYPE Center to discuss more about it.

c. West Portal Resolution

Chair Ansari said there was new information to incorporate into the resolution, which included comments around making it more general about the West Portal plan. Vice Chair Fong said that the West Portal community had rejected the initial proposal that SFMTA put out, to which Specialist Ochoa said that the initial plan was never final and was proposed to gather community input in the first place. Chair Ansari said their resolution language seems pretty general already, but that they can add language that includes the committee process. Vice Chair Fong added that the survey language can be removed since it's no longer open for responses.

Chair Ansari said that she would propose any language amendments at the next full Youth Commission meeting later on May 20th.

d. HRT-related Updates

Commissioner Adair and Vice Chair Fong said that everyone should try and take a picture with their appointing officer when doing advocacy.

Vice Chair Fong said he will try and see what the youth representation looks like at the West Portal Welcoming Committee.
