1	[Youth Comission Sponsorship of the Redefining Education Project]
2	Declaring the Youth Commission's sponsorship of the Redefining Education Project, including
3	a November 18 th , 2012 Redefining Education Conference.

5	Whereas, high school is undeniably important in the education of young people,
6	preparing youth to thrive as adults and to be responsible members of society; and
7	Whereas, students are often not involved in shaping their own educational experience
8	and are not aware that they should and can do so; and
9	Whereas, even if students should speak up, their voices often aren't heard; and
10	Whereas, current assessment based education discourages students from talking
11	about important life questions in the classroom (i.e. what does it mean to be successful?); and
12	Whereas, there is a need to provide a structure in which students can ponder and
13	discuss such important questions; and
14	Whereas, this identified need is common to both public and private schools; and
15	Whereas, the Redefining Education Project's goals are threefold: (1) to motivate
16	students to contemplate and discuss pertinent life questions; (2) to involve students in shaping
17	their own educational experience; and (3) to create a structure for students and teachers to
18	come together in addressing these questions; and
19	Whereas, the Redefining Education Project consists of a fall conference and
20	subsequent spring events;
21	Whereas, the Redefining Education Conference will bring together 50 high school
22	students and teachers to think critically and develop ideas about how to refocus high school
23	on questions that are relevant to youth, and to plan spring events that will implement these
24	ideas around the bay area; and
25	Whereas, the Redefining Education Conference facilitates discussion between

1	students and teachers about certain important education topics such as the extent of
2	memorization in classrooms, the usefulness of homework, the affect of standardized testing,
3	and the role school should play in exploration of ethical and moral questions; and
4	Whereas, the Redefining Education Conference is designed to empower students and
5	teachers to actively work together to bring change to their educational communities; and
6	Whereas, the conference will be held on November 18 th , 2012 at 755 Ocean Avenue,
7	San Francisco, California 94114; now, therefore, be it
8	Resolved, that the San Francisco Youth Commission hereby sponsors the Redefining
9	Education Project, including the Redefining Education Conference; and be it further
10	Resolved, that the Youth Commission urges all youth and teachers to participate in the
11	Redefining Education Project by contacting the Youth Commission; and be it further
12	Resolved, that the Youth Commission also urges the BOS, the mayor, and DCYF to
13	spread awareness of the project and the related educational issues to all SF young people,
14	families, and those involved in education; now be it finally
15	Resolved, that the Youth Commission urges SFUSD to co-sponsor the Redefining
16	Education Project and Conference.
